3 **Ordinance authorizing settlement of the lawsuit filed by Erin Sheeran, as Conservator**
4 **for Cara Sheeran, against the City and County of San Francisco for \$97,500; the lawsuit**
5 **was filed on July 25, 2018, in San Francisco Superior Court, Case No. CGC-18-568392;**
6 **entitled Erin Sheeran, as Conservator for Cara Sheeran v. City and County of San**
7 **Francisco, et al.; the lawsuit involves alleged personal injury by San Francisco Fire**
8 **Department employees.**

10 Be it ordained by the People of the City and County of San Francisco:

11 Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby
12 authorizes the City Attorney to settle the action entitled Erin Sheeran, as Conservator for Cara
13 Sheeran v. City and County of San Francisco, et al., San Francisco Superior Court, Case No.
14 CGC-18-568392 by the payment of \$97,500. The lawsuit involves alleged personal injury by
15 San Francisco Fire Department employees.

16 Section 2. The above-named action was filed in San Francisco Superior Court on July
17 25, 2018, and the following parties were named in the lawsuit: Plaintiff Erin Sheeran, as
18 Conservator for Cara Sheeran; Defendants City and County of San Francisco, Raymond Lee,
19 and Ryan Jamison.
