2 and T.A., a Minor, By and Through Her Guardian - \$150,000]

3 **Ordinance authorizing settlement of the lawsuit filed by Rashad Abdullah, individually**
4 **and as the guardian for minor T.A.; and T.A., a minor, by and through her guardian**
5 **against the City and County of San Francisco for \$150,000; the lawsuit was filed on**
6 **September 3, 2019, in the United States District Court, Northern District of California,**
7 **Case No. 19-cv-05526-LB; entitled Rashad Abdullah, et al. v. City and County of San**
8 **Francisco, et al.; the lawsuit involves alleged civil rights violations.**

10 Be it ordained by the People of the City and County of San Francisco:

11 Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby
12 authorizes the City Attorney to settle the action entitled Rashad Abdullah, et al. v. City and
13 County of San Francisco, et al., United States District Court, Northern District of California,
14 Case No. 19-cv-05526 LB by the payment of \$150,000. The lawsuit involves alleged civil
15 rights violations.

16 Section 2. The above-named action was filed in United States District Court, Northern
17 District of California on September 3, 2019, and the following parties were named in the
18 lawsuit: Plaintiffs Rashad Abdullah, individually and as the guardian for minor T.A.; and T.A.,
19 a minor, by and through her guardian; Defendants City and County of San Francisco, San
20 Francisco Juvenile Probation Department, former Chief Allen Nance, Deputy Probation Officer
21 Moegagogo Tamasese, Deputy Probation Officer Lyudmila Baranov.
