

## **Budget Reduction Criteria**

- In determining reductions to put forward, the Department considered various factors, including:
  - Impact on the Department's core business operations;
  - Safety of victims of crime and San Francisco residents as a whole;
  - Reductions that did not impede efforts to safely reduce the vulnerable and racially disproportionate jail population;
  - Impact on non-profit/community-based organization service delivery for communities of color;
  - Avoiding staff layoffs.
