3 **Ordinance authorizing settlement of the lawsuit filed by Anthony Economus against the**  
4 **City and County of San Francisco for \$275,000; the lawsuit was filed on May 2, 2019, in**  
5 **San Francisco Superior Court, Case No. CGC-19-575669; entitled Anthony Economus v.**  
6 **Flint Paul; the lawsuit involves an alleged civil rights violation.**

8 Be it ordained by the People of the City and County of San Francisco:

9 Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby  
10 authorizes the City Attorney to settle the action entitled Anthony Economus v. Flint Paul, San  
11 Francisco Superior Court, Case No. CGC-19-575669 by the payment of \$275,000. The  
12 lawsuit involves an alleged civil rights violation occurring on July 11, 2017.

13 Section 2. The above-named action was filed in San Francisco Superior Court on May  
14 2, 2019, and the following parties were named in the lawsuit: Plaintiff: Anthony Economus,  
15 and Defendant: Flint Paul.
