9 Be it ordained by the People of the City and County of San Francisco:

10 Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby
11 authorizes the City Attorney to settle the action entitled Oliver Barcenas, et. al v. City and
12 County of San Francisco, et. al, San Francisco County Superior Court, Case No. CGC-19-
13 575896, by the payment of \$180,000. The lawsuit involves alleged civil rights violations.

14 Section 2. The above-named action was filed in San Francisco County Superior Court
15 on May 10, 2019, and the following parties were named in the lawsuit: Plaintiffs: Oliver
16 Barcenas and Sofia Barcenas; Defendants City and County of San Francisco, San Francisco
17 Police Department and Joshua Cabillo.
