3 **Ordinance authorizing settlement of the lawsuit filed by Thaïs Yafet against the City**
4 **and County of San Francisco for \$110,000; the lawsuit was filed on October 29, 2018, in**
5 **San Francisco Superior Court, Case No. CGC-18-570939; entitled Thaïs Yafet v. City**
6 **and County of San Francisco; the lawsuit involves an alleged injury when Plaintiff**
7 **tripped and fell on a City sidewalk.**

9 Be it ordained by the People of the City and County of San Francisco:

10 Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby
11 authorizes the City Attorney to settle the action entitled Thaïs Yafet v. City and County of San
12 Francisco, San Francisco Superior Court, Case No. CGC-18-570939 by the payment of
13 \$110,000. The lawsuit involves an alleged injury when Plaintiff tripped and fell on a City
14 sidewalk.

15 Section 2. The above-named action was filed in San Francisco Superior Court on
16 October 29, 2018, and the following parties were named in the lawsuit: Plaintiff: Thaïs Yafet,
17 Defendant: City and County of San Francisco.
