5 **lawsuit was filed on May 6, 2019, in San Francisco Superior Court, Case No.**
6 **CPF-19-516659; entitled Lina Lu et al. v. City and County of San Francisco et al.; the**
7 **lawsuit involves a challenge to the San Francisco Police Department's procedures for**
8 **producing incident reports in domestic violence cases; other material terms of the**
9 **settlement are the adoption of changes in City protocols for producing domestic**
10 **violence incident reports.**

12 Be it ordained by the People of the City and County of San Francisco:

13 Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby
14 authorizes the City Attorney to settle the action entitled Lina Lu et al. v. City and County of
15 San Francisco, et al., San Francisco Superior Court, Case No. CPF-19-516659 by the
16 payment of \$49,00 in attorneys' fees and the adoption of certain changes in the San
17 Francisco Police Department's procedures for producing domestic violence incident reports
18 under California Family Code § 6228. The lawsuit involves a claim that the Police Department
19 was not producing incident reports in a timely way and was redacting the reports in a way that
20 the law did not permit.

21 Section 2. The above-named action was filed in San Francisco Superior Court on May
22 6, 2019, and the following parties were named in the lawsuit: Plaintiffs Lina Lu, Alexandra
23 Anderson, and Stella Osborne, and Defendants City and County of San Francisco, San
24 Francisco Police Department, and William Scott in his official capacity as Chief of Police.
