3 **Ordinance authorizing settlement of the lawsuit filed by Dennis Caruso against the City**  
4 **and County of San Francisco for \$70,000; the lawsuit was filed on November 8, 2019, in**  
5 **San Francisco Superior Court, Case No. CGC-19-580664; entitled Dennis Caruso v. City**  
6 **and County of San Francisco; the lawsuit involves an alleged injury when Plaintiff hit a**  
7 **pothole on a City Street and was thrown from his scooter.**

9 Be it ordained by the People of the City and County of San Francisco:

10 Section 1. Pursuant to Charter, Section 6.102(5), the Board of Supervisors hereby  
11 authorizes the City Attorney to settle the action entitled Dennis Caruso v. City and County of  
12 San Francisco, San Francisco Superior Court, Case No. CGC-19-580664 by the payment of  
13 \$70,000. The lawsuit involves an alleged injury when Plaintiff hit a pothole on a City Street  
14 and was thrown from his scooter.

15 Section 2. The above-named action was filed in San Francisco Superior Court on  
16 November 8, 2019, and the following parties were named in the lawsuit: Plaintiff: Dennis  
17 Caruso, Defendant: City and County of San Francisco.
