Re: Public Art

Dear Commission Members,

I attempted to comment during the August 19, 2020 meeting regarding "The History of Medicine in California" frescoes at UCSF. However, I was defeated by digital technology although I pressed *3 several times. I do endorse the landmark designation of the murals

My comment is now a more general one, but it will provide context to your action on the murals and hopefully future action.

As a resident of Berkeley, I am very familiar with university overreach and lack of concern for issues of concern in the surrounding community. The proposed destruction of public art at UCSF fits this pattern of arrogant and irresponsible disregard for the community.

This also raises some policy issues that need examination. UCSF in its construction at Mission Bay had a robust public art program that was championed by the chancellor. However, the current administration has not prioritized public art in it plans for its new Parnassus Heights buildings. In a multi-billion dollar project, even a small percentage dedicated to public art would provide a plenty of funds for reinstallation of the Zakheim murals and the commissioning of a great deal of public art.

I'm sure you are well aware that San Francisco has a percent for art program, as does other California cities and 23 states. However, California has no statewide mandated percent for art program. This allows UCSF to sidestep the issue of both preservation of its historic art and commitment to developing an art program in its proposed massive project.

I urge the commission to work take action to encourage the development of a statewide percent for art program in public buildings. Urging the Board of Supervisors to work with other cities and its legislative delegation would help to make this issue more visible and hopefully lead to state policy to correct this lack of concern for public art in California.

Dear Commissioners.

I hope to take part in your hearing today by calling in, but I am providing this written material in case that doesn't work.

I encourage you to support agenda item 11, the landmarking of Bernard Zakheim's murals at Toland Hall, UCSF. I do so because I am confident that those murals meet the standards for landmarking set by the Secretary of the Interior: they are associated with events that have made a significant contribution to the broad patterns of our history (the New Deal arts programs), they are associated with the lives of persons significant in our past (Bernard Zakheim, Chauncey Leake, the chancellor who commissioned the murals and appears in one of them, and other the historical figures depicted in the murals), they represent the work of a master (Zakheim), and they possess high artistic values.

During the 1930s, Zakheim was one of the leading artists in this area who were creating major public art under the auspices of the New Deal arts programs. During the 1930s, Zakheim created the following public art, all still extant:

- Jewish Wedding also called Jewish Festival, private commission, Jewish Community Center, San Francisco, 1933, relocated in the new JCC building in 2004.
- *Library,* Coit Tower, San Francisco, 1934. National Register of Historic Places, 07001468; San Francisco Landmark 165.
- Community Spirit and Growth, two murals, Alemany Emergency Hospital and Health Center. San Francisco. 1934. San Francisco Landmark 272.
- Ancient Medicine and Modern Medicine, two murals, Cole Hall, UCSF, San Francisco, 1935, relocated to Health Sciences West, 1966.
- The Story of California Medicine, ten murals, Toland Hall, UCSF, San Francisco, 1938.
- The Horse and Buggy Era Gives Way to Modern Transportation, Post Office, Mineola, Texas, 1938.
- Agriculture and Industry, Post Office, Rusk, Texas, 1939.

After completing his last New Deal commissions, Zakheim did a series of paintings of figures from the American Revolution. The Holocaust was enormously influential for Zakheim, and he began creating works depicting Jewish life and the Holocaust, including two major works of public art: *Songs of the Polish Jews* also called *The History of the Jews Through Song* (mural, 1961, near Warsaw, Poland), and *Memorial*

to the Six Million also called Warsaw Ghetto Memorial (six sculptures, Mount Sinai Memorial Park, Los Angeles, 1966). Throughout his career, he continued to create oil paintings and watercolors.

Zakheim's murals are also excellent examples of the public art produced by New Deal programs. He included social commentary in several places, something typical of much New Deal art. Bruce Bustard, in his 1997 study of New Deal art programs, specified five themes typical of New Deal art, of which three can be found in the Toland Hall murals: a celebration of ordinary, often working-class, people (including Biddie Mason, a Black woman and former enslaved person); promotion of social change (including a celebration of the first woman to graduate from what became UCSF); and a rediscovery of American history (Zakheim's extensive research is reflected in the murals by scrolls or documents identifying the individuals and events he was depicting).

I hope that I can be present virtually during your meeting to answer any question you may have.
