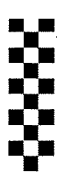



I am an African American woman whose pronouns are she and hers. I have spent the better part of a thirty five year career working in public health in hopes of helping communities of color. Many of these communities resemble, in every way, the community of my youth. A community scarred by violence, addiction, poverty, intergenerational racism, trauma, mental illness, low education, fragile employment and fragile housing. These factors led and lead to high rates of stress and trauma further contribute to rising rates of addiction, mental illness, morbidity and mortality. We know that poverty and inequality are determinants of health and wellbeing. My interest in my own community led me to study addiction, alcohol use and determinants of behavior change. Over the years I have poured my energy into ending violence, working with community based organizations to stop the spread of HIV through safe injection sites and safer sex education. My practice focus has included mental illness, complex trauma, addiction, sex work, sex trafficking, violence and homelessness. Often these are inextricably linked further complicating a coordinated and effective health care response. My work has centered on identifying, fortifying existing community strengths and partnerships, public education, advocacy and outreach to communities of color and at risk cohorts such as youth, and LGBTQ. All too often black and brown communities have limited resources, limited education, limited voice and power. They suffer from disparate access to health care, education, employment and housing. Resultantly they have a higher burden of illness, trauma, injury, disability and death. I am deeply committed to insuring that all people regardless of gender, age, race, ethnicity, religious preference have access to quality health care as a basic right.

It is a great honor to write a letter of recommendation for Philip Jones. Mr. Jones has been known to me for four years, in a variety of capacities. He is smart, empathic and driven, and is / always has been a pleasure to work with.

I initially met Philip when he was a participant in Behavioral Health Court (BHC). He had been known to the San Francisco Jails for the four years prior, with challenges both in custody and out. In 2015, Philip decided to give 100% to his treatment and followed through until completion. He was an active participant in every which way – in custody, he began participating in groups and sessions. Once released to a treatment program, Philip's weekly reports from staff were excellent – he was frequently on the court's Honor Roll for being engaged in his treatment, participating fully and adhering to the many requests made of him. He appeared in court regularly, was not using substances and was seen as a leader among his peers.

In May of 2016, Mr. Jones graduated successfully from Behavioral Health Court. He was committed to healthy living and to helping others succeed. Philip was working in a bicycle vocational store, participating in creating a smart-phone soccer application, and coaching at-risk youth in soccer. In each area, Philip's commitment and hard work resulted in excellent outcomes – he was offered additional responsibility at the bike shop, was flown to France to showcase his app, and went to Germany with the youth soccer league.

Philip has decided to commit himself to pursuing social justice and helping others who have walked in a similar path. Philip is an example of strength and follow-through. He accepted a position on our Mentorship And Peer Support (MAPS) Team, an invaluable resource that our collaborative court participants have at their disposal – someone with lived experience who is showing us all that people can and do recover. Histories of justice involvement, substance use and trauma can, as Philip demonstrates regularly, be strengths and tools. As a MAPS mentor, Mr. Jones helps people get through their criminal justice obligations, and come through the other side healthy and with renewed sense of self.

In his work with MAPS, Philip was recruited to provide peer services to people on probation. He has been working in both capacities, while returning to school and completing his Associates Degree. As Philip moves forward with his Bachelors and, eventually, Master of Social Work, he continues to meet his clients where they are at – contemplating some healthy changes, leaving justice involvement in their pasts and living their best life.

Watching Philip navigate the criminal justice and social service worlds brings me joy. I have told him, on several occasions, that upon receiving his MSW, I would be delighted to have him as a member of my clinical team. Philip Jones is a shining example to all of us, proving that we can all achieve what we set our minds to. **1. Qualifications:**

I am a 28-year-old African American and Latin x male. I am a Bay Area native and have lived in San Francisco for 10 years, I went to grade school in San Francisco as well. I was diagnosed with bipolar 1 when I was 19. I have been living with my bipolar for almost 10 years now, I also had an IV drug addiction during the first five years of receiving my diagnosis. I was homeless from 19-24 here in the city and as a result have stayed at many of the homeless shelters and received various services through case management or other homeless city resources. I received county services for both my mental health and substance abuse problems. I got treatment in Jail Psych Services when in custody and in the community, I got Medi-Cal services for my mental health at Mission Mental Health. I went to treatment at Progress House through Progress Foundation where they take Medi-Cal and Government Assistance. I was 23 when I arrived there, and the program specializes in the treatment of persons who are diagnosed with co-occurring disorders. I have been sober and successfully living with my mood disorder for 5 years. I have been able to manage treatment, medications, and recovery while living a constructive lifestyle. I am the perfect candidate to bring the perspective of what it is like to be a homeless person of color suffering from mental health issues with a substance abuse disorder on top of it in San Francisco. Also, as someone who has been in the justice system starting from a teen, I bring a unique knowledge of what it is to receive and navigate services in custody. I bring a viewpoint that is very crucial to the services and support we try to establish as a community here in San Francisco.

**2. Business and or Professional Experience:**

As a professional I have worked in mental health, substance abuse, and the justice system for over a year and a half. In my current role I work with U.C.S.F. Psychiatry City Wide Division as a Peer Case Manager working with clientele who have co-occurring disorders and who are all at risk of or are currently experiencing homelessness. I also work as a peer mentor through the M.A.P.S program with Jail Behavioral Health Services. I work with clients with moderate to severe mental health conditions trying to navigate the justice system here in San Francisco. Most of my clientele are involved in behavioral health court which requires a guilty plea and an existing mental health condition to be enrolled. I have extensive knowledge of what it takes to be a service provider working in the fields of mental health, substance abuse, homeless services, and the justice system.

**3. Civic Activities:**

Throughout my time as a member of the San Francisco community I have volunteered and engaged in public service. I volunteered as a head coach for Street Soccer USA coaching at risk youth in the tenderloin district in San Francisco. Later I would serve on the board for this organization overlooking programs and events. I currently serve on the Community advisory Board for Tipping Point; in this role I oversee Nonprofits being created and established and weigh in using my experience and expertise. Also, part of this commitment is overseeing their All-In homeless initiative which entails creating supportive housing for people on the streets. I am currently a Junior at SF State pursuing my second degree in Social Work. At their prestigious School of Social Work, where they let in only 30 students a semester. I am active in the recovery

community as well with close to 5 years of sobriety I actively engage and help others navigate their substance abuse problems. I have and continue to be active in local communities to support those who are disadvantaged. I speak at events on my experience and knowledge as well as volunteer time locally to panels regarding the topics addressed. See resume for more.

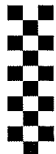



I have been a resident and worker in San Francisco since 1996. I identify as a bi-cultural Mexican American woman. For the past 26 years I have lived in the Mission District Neighborhood, and worked in community based organizations serving the most socioeconomically disenfranchised residents of San Francisco. In all my professional work experience I have served primarily persons of color, with an emphasis on immigrant communities. When I worked at La Casa de Las Madres, my caseload was entirely comprised of immigrant Latinx and Asian women as well as African American women. I went on to work at the Mission Neighborhood Health Center HIV program, Clinica Esperanza, where close to 90 percent of my clients were Latinx immigrants, primarily LGBTQ identified. It was there that I gained valuable experience in learning about the intersecting impacts of political persecution, displacement, and low socioeconomic status on healthcare access and outcomes. I have now been working for over a decade as a mental health clinician. In this role every day we are faced with the intersection of poverty, racism, sexism, homophobia, transphobia, trauma and poor health outcomes. I have been drawn to this work by a deeply engrained sense of social justice. My grandfather was a leader in the UFW in our local community of Sanger, California. I grew up learning of the struggle and even travelled to Delano with my grandparents to see Cesar Chavez during his hunger strikes. I also have personal experience with my brother who is mentally ill and currently serving prison time for a violent act that he committed. I identify with the families of our clients whose loved one has committed acts in the midst of a mental health crisis and who are wanting so much for community support and intervention to turn their loved one's life around. I believe that Mental Health SF can be a major turning point in our community toward helping not just the clients that I work with, but also their families and extended community, to achieve health and wellness.

Dear Members of the Board of Supervisors:

It is with great pleasure and honor that I write this letter of recommendation for Andrea Salinas, MFT, for Seat 7 on the Mental Health SF Implementation Workgroup, as a representative of UCSF Citywide Case Management (Citywide), a Division of the Department of Psychiatry and Behavioral Sciences. Citywide is comprised of multiple programs each with specific goals and directionality, but all with the purpose of serving the most vulnerable and socially disadvantaged severely mentally ill San Franciscans. As such, Citywide provides more than half of the current intensive case management (ICM) services (outreach-based wrap-around psychosocial and behavioral health treatment) slots in the City of San Francisco. We have a program dedicated to work with justice-involved clients, serving nearly 400 San Franciscans who fit this criterion; and many clients not formally a part of this program, touch on the criminal justice system. In addition to what is classically defined as ICM, Citywide provides "Crisis ICM" through rapid linkage of clients from hospitals and short-term ICM rendered to Shared Priority clients. Citywide also works in supportive housing, supported employment and vocational programming, provides peer-led day treatment program, and has a robust medical psychiatric component staffed by UCSF faculty.

Ms. Salinas currently serves as a clinical social work supervisor for the Cross Currents Team, one of the intensive case management teams of the Citywide Focus Case Management program, which serves over 400 clients. The team's task is to serve individuals who experience severe mental illness, co-occurring substance use, homelessness, and chronic medical conditions. These clients are thus in need of wrap around intensive psychosocial, mental health and medical supports. Cross Currents has a cultural focus and clinical capacity to serve women, and clients who identify as LGBTQ. As a clinical social work supervisor, Andrea carries her own caseload, and maintains clear sight of the needs of clients and the gaps encountered when providing direct service. At the same time, she provides clinical supervision to a team of providers, which gives her a more macro-level perspective on the issues. From a more personal level, she identifies as Latinx, and has worked extensively with Latinx and African immigrant clients. She has developed expertise on the particular needs of and systems of care deficits (including that of the legal system) faced by these populations.

Ms. Salinas' path and professional activities indicate a passion for understanding and solving the larger issues faced by the population we serve and, frankly, faced by our community. She has participated in the DPH Workgroup to Re-envision the Jail Replacement Project, and thus has intimate understanding of the issues faced by justice-involved individuals. Her training is grounded in the theories of evidence-based mental health practices focused on the individual, but her inclination is to marry that micro-level person to person therapeutic knowledge to the macro-level systems level perspective. Her path indicates a sustained interest in issues of homelessness and housing, immigration, and the holistic care of the whole person through integration of behavioral and physical healthcare.

I deeply appreciate your consideration of her candidacy and the representation of UCSF Citywide on this important Workgroup.

This network later bloomed into and merged with Occupy SF and related projects.

I am 20 year resident of San Francisco's Mission District. I am a queer, 49 year-old, white, Jewish woman. I work in homeless services and currently work and serve low income residents of the Tenderloin neighborhood. I am also the family member of an uncle who lives with chronic, severe mental illness, who has been in varying levels of mandated care over his lifetime.

**Business and/or professional experience:**

I have over 20 years of professional experience advocating on behalf of and providing services to low income individuals and communities. I have worked in non-profit, community-based organizations in the areas of affordable housing, tenant's rights, and homelessness. My direct work with clients has primarily been with residents of SROs, Public Housing and Section 8 renters and people experiencing homelessness. I spent three years coordinating a multi-disciplinary homeless outreach team on LA's Skid Row, where I became intimately familiar with the issues of chronic mental illness among those living on the streets. Along with our team's mental health clinicians and outreach staff from the Department of Mental Health, we addressed many cases of severe and persistent mental illness where we utilized the County's mental health system of care, including the 5150 process, the Assisted Outpatient Program and the office of Conservator. Currently, I work for Community Housing Partnership, which is a supportive housing provider that provides homes and services to people experiencing homelessness. CHP has 1700 units of affordable housing, many of which are SROs in the Tenderloin and the Central City and includes family housing on Treasure Island and a Navigation Center at the Civic Center Hotel. I have a Master's in Social Work (MSW) degree from San Francisco State University. As staff to the Treatment on Demand Coalition, I have become very familiar with mental health and substance use systems of care.

Administrative Code, Article XLIV (Ordinance No. 300-19)

The **Mental Health SF Implementation Working Group** was established to *advise the Mental Health Board or any successor agency, the Health Commission, the Department of Public Health, the Mayor, and the Board of Supervisors, and may advise the San Francisco Health Authority, on the design, outcomes, and effectiveness of Mental Health SF, established by Section 15.104 of the Administrative Code.*

The Working Group shall consist of thirteen (13) members.

- Seat 1 shall be held by a person with expertise working on behalf of healthcare workers, appointed by the Board of Supervisors.
- Seats 2 and 3 shall each be held by a person who identifies as having a mental health condition or identifies as having both a mental health condition and substance use condition (“dual diagnosis”), and who has accessed mental health or substance use services in San Francisco, appointed by the Mayor and the Board of Supervisors, respectively.
- Seat 4 shall be held by a City peace officer, emergency medical technician, or firefighter (“First Responder”) with expertise in mental health and/or substance use treatment, appointed by the Mayor.
- Seats 5 and 6 shall each be held by a substance use treatment provider with expertise in mental health treatment and harm reduction, appointed by the Mayor and the Board of Supervisors, respectively.
- Seat 7 shall be held by a mental health or substance use treatment provider with experience working with criminal system-involved patients, appointed by the Board of Supervisors.
- Seat 8 shall be held by a psychiatrist or other behavioral health professional with expertise providing services to transitional age youth (ages 18-24) in San Francisco, appointed by the Board of Supervisors.
- Seat 9 shall be held by a person with experience in the management or operation of residential treatment programs, appointed by the Mayor.
- Seat 10 shall be held by an employee of the Department of Public Health with expertise in working with dually diagnosed persons, appointed by the Mayor.
- Seat 11 shall be held by a person with experience providing supportive housing in San Francisco, appointed by the Board of Supervisors.
- Seat 12 shall be held by an employee of the Department of Public Health with experience in health systems or hospital administration, appointed by the Mayor.

- Seat 13 shall be held by a person with expertise in the field of health law, appointed by the City Attorney.

Members shall serve for a two year term beginning June 1, 2020, provided, however, the term of the initial appointees in Seats 1, 3, 5, 7, 9, and 11 shall be one year, expiring on June 1, 2021.

The Department of Public Health shall provide administrative and clerical support for the Implementation Working Group.

#### Reports:

The Implementation Working Group shall work with the Controller and the Department of Human Resources to conduct a staffing analysis of both City and nonprofit mental health services providers to determine whether there are staffing shortages that impact the providers' ability to provide effective and timely mental health services. If the staffing analysis concludes that there are staffing shortages that impact timely and effective service delivery, the staffing analysis shall also include recommendations regarding appropriate salary ranges that should be established, and other working conditions that should be changed, to attract and retain qualified staff for the positions where there are staffing shortages.

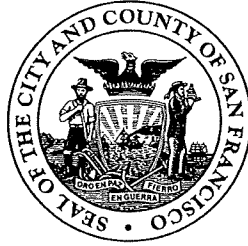
By no later than October 1, 2020, and every year thereafter, the Implementation Working Group shall submit to the Board of Supervisors, the Mayor, and the Director of Health a written report on its progress.

By no later than June 1, 2021, the Implementation Working Group shall submit to the Board of Supervisors, the Mayor, and the Director of Health its final recommendations concerning the design of Mental Health SF, and any steps that may be required to ensure its successful implementation.

Within six months of the effective date of this Article XLIV, the Implementation Working Group shall submit to the Mayor, the Board of Supervisors, and the Director of Health the staffing analysis required by subsection (b).

Sunset Date: This Article XLIV shall expire by operation of law, and the Implementation Working Group shall terminate, on September 1, 2026. After its expiration, the City Attorney shall cause this Article XLIV to be removed from the Administrative Code.
