Be it ordained by the People of the City and County of San Francisco:

Section 1. Article I of Chapter 10 of the Administrative Code is hereby amended by revising Section 10.20, to read as follows:

SEC. 10.20. BUDGET SAVINGS INCENTIVE FUND

(a) Establishment and Purpose of Budget Savings Incentive Fund. The Budget Savings Incentive Fund ("the Fund") is hereby established as a category eight fund for the purpose of encouraging City departments to implement cost-saving strategies and to allow for the reinvestment of those savings in one-time expenditures. Disbursements from the Fund shall be made only to those departments that generated net year-end expenditure savings at the close of the most recent prior fiscal year, as certified by the Controller, and only for the purpose of supporting one-time costs, including but not limited to expenditures that improve

- the efficiency of departmental operations, reduce the cost of service delivery, generate additional revenue, or meet deferred maintenance needs.
 - (b) Funding of Budget Savings Incentive Fund. It shall be the policy of the City and County of San Francisco that a Budget Savings Incentivethe Fund will be annually funded and available by November 1st of each year. At the end of each fiscal year, up to 25% percent of the total appropriation closed to General Fund balance by General Fund departments and the Department of Public Health's hospital funds shall be appropriated into the Fund (the "carry forward amount") and placed on Controller's reserve. The Controller may suspend the carry forward amount in years when the Controller determines that the City's financial condition cannot support deposits into the Fund.
 - (c) Request and Approval of Appropriation. Any department funded in whole or in part from the General Fund may submit a request in writing to the Controller's Office for a disbursement from the Fund. Requests shall be reviewed and recommended for funding by a working group comprised of the Mayor's Budget Director, the City Controller, and the President of the Board of Supervisors, or their designees. Recommendations of the working group shall be submitted to the Board of Supervisor's, and the Board may appropriate monies from the Fund by ordinance. Finance Committee for review, and subsequently submitted in the form of a resolution to the Board of Supervisors for approval, until which time the The Controller shall not release the reserve on monies deposited to the Fund until the City has finally enacted such an ordinance. This subsection shall go into effect in fiscal year 2006-2007, provided that year end General Fund savings from the preceding year are of an amount sufficient to meet the savings incentive reserve assumptions of the 2006-2007 budget pursuant to the pre-existing Section 3.17 of the Administrative Code.

1	(d) Upon approval of funding requests, the Controller shall have the authority to		
2	administratively transfer appropriations from the Fund to the department(s) for which requests		
3	were approved.		
4	(e) Fiscal Years 2020-21 and 2021-22. Notwithstanding the provisions of subsections (a)		
5	through (d), in fiscal years 2020-2021 and 2021-2022, monies in the Fund may be used for any purpose		
6	related to the City's response to the COVID-19 pandemic or the pandemic's economic impacts,		
7	provided the use is authorized in the Biennial Appropriations Ordinance or a supplemental		
8	appropriation ordinance. The restrictions on disbursements required by subsection (a), the placement		
9	of funds on Controller's reserve required by subsection (b), and the procedures for disbursements		
10	required by subsections (c) and (d) shall not apply. This subsection (e) shall expire by operation of law		
11	on July 1, 2022, after which the City Attorney shall cause the subsection to be removed from the		
12	Administrative Code. This ordinance may be amended to suspend the process for making		
13	appropriations from the Fund, as described in Section 10.20(c), for any single fiscal year to provide for		
14	an alternative use of amounts in the Fund.		
15	(f) For fiscal year 2009-2010, the process for making appropriations from the Fund, described		
16	in Section 10.20(c), is suspended, and all amounts in the Fund on June 30, 2009, shall be deposited into		
17	the General Fund to be used to assist in balancing the fiscal year 2009-2010 budget.		
18			
19	Section 2. Effective Date. This ordinance shall become effective 30 days after		
20	enactment. Enactment occurs when the Mayor signs the ordinance, the Mayor returns the		
21	ordinance unsigned or does not sign the ordinance within ten days of receiving it, or the Board		
22	of Supervisors overrides the Mayor's veto of the ordinance.		
23			
24	Section 3. Scope of Ordinance. In enacting this ordinance, the Board of Supervisors		
25	intends to amend only those words, phrases, paragraphs, subsections, sections, articles,		

1	numbers, punctuation marks, charts, diagrams, or any other constituent parts of the Municipal
2	Code that are explicitly shown in this ordinance as additions, deletions, Board amendment
3	additions, and Board amendment deletions in accordance with the "Note" that appears under
4	the official title of the ordinance.

[Administrative Code - Budget Savings Incentive Fund Expenditures]

Ordinance amending the Administrative Code to suspend the restrictions on expenditure of monies in the Budget Savings Incentive Fund during FY2020-2021 and FY2021-2022, and to authorize the use of monies in that Fund during those fiscal years for any purpose related to the City's response to the COVID-19 pandemic or the pandemic's economic impacts.

Existing Law

The City maintains a Budget Savings Incentive Fund to implement cost-saving strategies and reinvest those savings in one-time expenditures. Departments that have generated year-end savings may request disbursements from the Fund to support one-time costs, such as expenditures that improve the efficiency of departmental operations, reduce the cost of service delivery, generate additional revenue, or meet deferred maintenance needs. The Controller holds the funds until the Board of Supervisors approves the disbursements.

Amendments to Current Law

The proposed ordinance would suspend the restrictions on expenditure of money in the Budget Savings Incentive Fund during fiscal years 2020-21 and 2021-22. The ordinance would authorize departments to use those funds for any purpose related to the City's response to the COVID-19 pandemic or the pandemic's economic impacts, as long as the Board approves the spending in an appropriation ordinance.
