3 **Ordinance waiving, for a two-year period, permit and renewal fees in the Public Works**  
4 **Code for café tables and chairs in public sidewalks and roadway areas, and for display**  
5 **of fruits and vegetables or nonfood merchandise on public sidewalks; and waiving fees**  
6 **for use of parklets.**

14 Be it ordained by the People of the City and County of San Francisco:

15 Section 1. **Findings.**

16 (a) The COVID-19 shutdown has had a major adverse impact on the variety of  
17 small businesses that contribute to San Francisco's economic vitality, and experts are  
18 predicting that a third of the businesses shuttered during this time will never re-open.  
19 Whatever the precise number, it will be very large.

20 (b) Even when restaurants, cafes, and retail establishments are allowed to operate  
21 in some capacity, the space available to conduct their business activities and the number of  
22 customers who may be served are greatly curtailed due to social distancing requirements.

23 (c) Application and renewal fees present barriers to entry and unnecessary burdens  
24 to businesses seeking to avail themselves of permitted uses of public rights of way. The  
25 revenue to the City generated by those fees is low relative to the barriers to entry that they  
present to small businesses, in particular.

1 (d) The urgency of the COVID-19 response demonstrates that businesses are  
2 capable of implementing sidewalk and street encroachments pursuant to clear City guidelines  
3 designed to allow for safe pedestrian and disability access to public rights of way. The ability  
4 of businesses to self-implement has also alleviated some of the City's burden to oversee  
5 implementation, and to instead focus the City's resources on compliance with and  
6 enforcement of those guidelines.

7 (e) This ordinance will temporarily waive the fees for businesses to use sidewalk  
8 and other public spaces for dining and display of merchandise in order to support the  
9 continued operation of these businesses, most of which are suffering severe economic losses  
10 due to the COVID-19 pandemic.

11  
12 **Section 2. Fee Waivers.**

13 Notwithstanding the provisions of Public Works Code Section 2.1.1 or any other permit  
14 fee provisions of the Public Works Code, permit fees and annual renewal fees for the  
15 following are waived for the period set forth in Section 3:

- 16 (a) Tables and Chairs Permit pursuant to Article 5.2 (Sections 176 et seq.);
- 17 (b) Display Merchandise Permit pursuant to Article 5.3 (Sections 183 et seq.); and
- 18 (c) Fees for use of parklets.

19  
20 **Section 3. Duration of Fee Waiver Authorization.**

21 The fee waivers authorized in Section 2 shall expire on August 1, 2022 unless revised  
22 or extended by ordinance. As provided in Section 4, the Board of Supervisors intends that the  
23 fee waivers commence on August 1, 2020.

1           Section 4. **Effective Date; Retroactivity.**

2           (a)     This ordinance shall become effective 30 days after enactment. Enactment  
3 occurs when the Mayor signs the ordinance, the Mayor returns the ordinance unsigned or  
4 does not sign the ordinance within ten days of receiving it, or the Board of Supervisors  
5 overrides the Mayor’s veto of the ordinance.

6           (b)     Upon its effective date, this ordinance shall be retroactive to August 1, 2020.  
7 Any fees waived in this ordinance that are collected between August 1, 2020 and the  
8 effective date of this ordinance shall be promptly reimbursed by the City.

## **LEGISLATIVE DIGEST**

[Temporary Waivers of Permit Fees for Café Tables and Chairs and Display Merchandise in the Public Right-of-Way, and Use Fees for Parklets]

**Ordinance waiving, for a two-year period, permit and renewal fees in the Public Works Code for café tables and chairs in public sidewalks and roadway areas and for display of fruits and vegetables or nonfood merchandise on public sidewalks; and waiving fees for use of parklets.**

### Existing Law

Section 2.1.1 establishes fees for the use of the public right-of-way, sidewalk and roadway areas for café tables and chairs and the display of merchandise.

### Amendments to Current Law

This ordinance will waive for a two-year period the fees described above.

### Background Information

The COVID-19 shutdown has had a major adverse impact on the variety of small businesses that contribute to San Francisco's economic vitality, and experts are predicting that a third of the businesses shuttered during this time will never re-open. Whatever the precise number, it will be very large. Even when restaurants, cafes, and retail establishments are allowed to operate in some capacity, the space available to conduct their business activities and the number of customers who may be served are greatly curtailed due to social distancing requirements.

Application and renewal fees present barriers to entry and unnecessary burdens to businesses seeking to avail themselves of permitted uses of public rights-of-way. The revenue to the City generated by those fees is low relative to the barriers to entry that they present to small businesses, in particular.

The urgency of the COVID-19 response demonstrates that businesses are capable of implementing sidewalk and street encroachments pursuant to clear City guidelines designed to allow for safe pedestrian and disability access to public rights-of-way.

According to City Charter Section 2.105, all legislative acts shall be by ordinance and require the affirmative vote of at least a majority of the members of the Board of Supervisors.

## BACKGROUND

The COVID-19 pandemic and Shelter-in-Place Order have reduced restaurant dining and other small business activity. On June 11, 2020, San Francisco Health Officer issued an order allowing outdoor dining to reopen, after nearly three months of closure. On July 13, 2020, Governor Gavin Newsom ordered that indoor dining was prohibited statewide. On August 28, 2020, Governor Newsom unveiled a new tiered system that allowed certain businesses to open based on the case rate in each county and local health orders. As of the writing of this report, San Francisco is in the “red” State tier, which allows indoor dining at 25 percent of a restaurant’s capacity. However, City health officials have not permitted indoor dining to resume. Other service businesses, such as retail, may operate indoors but with limited capacity due to social distancing requirements.

The Public Works Code allows businesses to set up café tables and chairs on sidewalks and other public right-of-way but requires businesses to obtain permits and conform to guidelines issued by the Director of Public Works. According to the proposed ordinance, permit renewal fees are unnecessary burdens to businesses that seek to use public rights-of-way.

Public Works Order 203498 allows businesses to apply for permits to temporarily occupy sidewalks and parking spaces as part of the City’s “Shared Spaces” program and contains guidelines for use. Under that Order, these temporary permits expire December 31, 2020, unless extended by the City.

Public Works Order 183392 provides guidance for temporary installation of sidewalk extensions (parklets). That Order provides implementation guidance for sidewalk landscaping use permits allowed by Public Works Code Article 16, Section 810B.

## DETAILS OF PROPOSED LEGISLATION

This report is based on the proposed substituted ordinance (File 20-0786) to be submitted to the September 23, 2020 Budget and Finance Committee.

The proposed ordinance, as substituted, would:

- (1) codify the City’s Shared Spaces Program and extending it to December 31, 2022; and
- (2) waive for a two-year period retroactive from April 15, 2020 through April 15, 2022 permit renewal fees: (i) in the Public Works Code for café tables and chairs on public sidewalks and roadway areas and for display of fruits and vegetables or nonfood merchandise on public sidewalks, and (ii) imposed under Department of Public Works Order 183392 for use of parklets.

Consideration of the originally proposed ordinance at the September 16, 2020 Budget and Finance Committee meeting, was continued to allow sponsors to draft substituted. As of the writing of this report, the proposed substituted ordinance would:

- 1. Waive fees to businesses with renewal dates of April 15, 2020 or later. Any fees collected for café tables and chairs or display merchandise after April 15, 2020 would be reimbursed.
- 2. Waive fees through April 15, 2022.
- 3. Clarify that the parklet fees refer to those referenced in Public Works Order 183392.<sup>1</sup>
- 4. Extend the City’s Shared Spaces Program through December 31, 2022. As noted above, currently, under Public Order 203498, the temporary permits associated with this program expire December 31, 2020. Businesses with these Shared Spaces permits would not have to obtain table and chair or merchandise display permits from Public Works.

**Waiver of Fees**

The proposed ordinance would waive the Public Works fees shown in Table 1 below.

**FISCAL IMPACT**

According to Mr. Devin Macaulay, Public Works Budget Manager, Public Works received \$662,496 in fees for café tables and chairs, sidewalk merchandise display, and use of parklets in FY 2018-19, the last fiscal year before the COVID-19 pandemic. This amount includes both renewal fees, which would be waived by the proposed ordinance, as substituted, and new application fees, some of which would not be waived by the proposed ordinance, as substituted. Fee revenue is shown in Table 2 below.

## DETAILS OF PROPOSED LEGISLATION

The proposed ordinance would retroactively waive Department of Public Works (Public Works) permit and renewal fees for café tables and chairs in public sidewalks and roadway areas, for display of fruits and vegetables or nonfood merchandise on public sidewalks, and for use of parklets, for a period of two years, from August 2020 through July 2022.

The proposed ordinance would waive the Public Works fees shown in Table 1 below.

According to Mr. Bernie Tse, Public Works Senior Engineer, Public Works will request amending the proposed ordinance to make it retroactive to April 1, 2020. Public Works has not sent permit renewal letters to businesses that were due on April 15, 2020 and beyond. If the proposed ordinance were approved with the August 1, 2020 effective date, Public Works would have to invoice businesses with renewals due in April, May, June, and July 2020.

**FISCAL IMPACT**

According to Mr. Devin Macaulay, Public Works Budget Manager, Public Works received \$662,496 in fees for café tables and chairs, sidewalk merchandise display, and use of parklets in FY 2018-19, the last fiscal year before the COVID-19 pandemic. Fee revenue is shown in Table 2 below.

estimated fees waived over the two-year period of the proposed ordinance would be approximately \$1,324,992. However, due to the impact of the COVID-19 pandemic on small business, and the number of businesses that have already permanently closed, the actual amount of fees waived by the proposed ordinance would likely be less than this amount.

Small Business Commission Recommendation to the Board of Supervisors: **Support with modifications.**

Dear Ms. Calvillo,

On August 10, 2020 the Small Business Commission (SBC or Commission) heard BOS File No. 200786 – Temporary Waivers of Permit Fees for Café Tables and Chairs and Display Merchandise in the Public Right-of-Way, and Use Fees for Parklets. Lee Hepner, Legislative Aide to Supervisor Aaron Peskin provided the SBC with an overview of the legislation. After discussion, the SBC voted (7-0) to recommend that the Board of Supervisors support the legislation with modifications.

The Commission applauded this legislation and extended their appreciation to the sponsor's office. They observed that although the genesis of the legislation predates the current emergency, this proposal is responsive to specific recommendations for small business support that the [Commission made to the Economic Recovery Task Force](#) to waive fees collected by regulatory agencies. The Commission emphasized that the ability for small businesses to utilize the public right of way for tables and chairs, display merchandise, and parklets helps to generate sales tax revenue, supports local jobs, and contributes to the beautification of the City. They discussed whether the legislative sponsor's office would be amenable to an amendment to extend the fee waivers in question in perpetuity. Mr. Hepner affirmed that they would consider the SBC's recommendations.

Responsive to a significant number of public commenters, the Commission discussed fees that have been assessed to small businesses for the use of park space by the Recreation and Parks Department during the pandemic, specifically fitness studios. Where \$15 per hour is currently being assessed to these businesses for the use of City park space, the Commission also discussed whether the legislative sponsor's would be amenable to including a waiver of this fee in the proposed legislation. Mr. Hepner affirmed that he would research this and contemplate it further.

Ultimately, the Commission voted unanimously to support the legislation with the following modifications:

- Amend Section 3 of the legislation and waive the fee for tables and chairs, display merchandise, and parklets in perpetuity;
- Amend Section 2 to include a waiver of Recreation and Park fees for assessed to outdoor fitness providers for the use of park space.
