On August 24, 2020, a memo was sent to all Members of the Board of Supervisors, surveying their interest in serving to the outside boards and commissions.

Summary:

- Association of Bay Area Government (ABAG) All Supervisors declined the opportunity to be appointed to Seats 3 and 4.
- Bay Area Air Quality Management District (BAAQMD) All Supervisors declined the opportunity to be appointed.
- Behavioral Health Commission All Supervisors declined the opportunity to be appointed to seat 17.
- California State Association of Counties (CSAC) (Reimbursed for up to \$1,000) Supervisor Mandelman expressed interest in this body, therefore, we will forward his nomination to the Rules Committee.
- Children and Families First Commission All Supervisors declined the opportunity to be appointed to Seat 1, therefore, the Commission will not have Board of Supervisors representation.
- Golden Gate Bridge, Highway and Transportation District (GGBHTD) All Supervisors declined the opportunity to be appointed to seat 7.
- Health Authority All Supervisors declined the opportunity to be appointed to seat 1, there the authority will not have Board representation.
- Local Agency Formation Commission (LAFCo) (Stipend \$100 per meeting) All Supervisors declined the opportunity to be appointed to Seats 1 and 5.
- San Francisco Int' l Airport (SFO) Community Roundtable All Supervisors declined the opportunity to be appointed to the alternate Seat 2.
- Urban Counties Caucus All Supervisors declined the opportunity to be appointed to Seat 1, therefore, the caucus will not have Board of Supervisors representation.

For all the remaining vacancies, we will poll again in December. When the new Board is sworn in, we will poll again in January.
