

1 [Consolidation of Elections Scheduled for November 3, 2020]

3 **Resolution consolidating the following elections, all of which will be held on November**
4 **3, 2020: the State of California General Election; the City and County of San Francisco**
5 **Municipal Election; the City and County of San Francisco Special Bond Election; the**
6 **Bay Area Rapid Transit District Election; the San Francisco Unified School District**
7 **Board of Education Election; the San Francisco Community College Board of Trustees**
8 **Election; and Peninsula Corridor Joint Powers Board District Special Tax Election; and**
9 **providing that the election precincts, voting places, and officers for these elections**
10 **shall be the same as for the State General Election.**

12 WHEREAS, The State of California will hold a general election on November 3, 2020,
13 for the purpose of voting on candidates for federal and state offices, as well as proposed state
14 ballot measures to be submitted to the voters; and

15 WHEREAS, The City and County of San Francisco will hold a municipal election on
16 November 3, 2020, for the purpose of voting on candidates for local office and proposed local
17 ballot measures to be submitted to the voters; and

18 WHEREAS, The Board of Supervisors has called a special election to be held in the
19 City and County of San Francisco on November 3, 2020, for the purpose of voting on a
20 proposed general obligation bond measure, and consolidated the special municipal bond
21 measure election with the State of California General Election scheduled for the same date;
22 and

23 WHEREAS, The Bay Area Rapid Transit (BART) District will hold a district election on
24 November 3, 2020, for the purpose of voting on candidates for the BART Board of Directors,

1 and requested that the district election be consolidated with the State of California General
2 Election scheduled for the same date; and

3 WHEREAS, The San Francisco Unified School District will hold an election on
4 November 3, 2020, for the purpose of voting on candidates for the Board of Education (School
5 Board); and

6 WHEREAS, The San Francisco Community College District will hold an election on
7 November 3, 2020, for the purpose of voting on candidates for the Board of Trustees for the
8 Community College District (City College Board); and

9 WHEREAS, The Peninsula Corridor Joint Powers Board has called a special election
10 to be held in the City and County of San Francisco on November 3, 2020, for the purpose of
11 voting on a proposed special tax measure, and requested that the special tax measure
12 election be consolidated with the State of California General Election scheduled for the same
13 date; and

14 WHEREAS, The Board of Supervisors believes that it is in the best interests of the
15 public that these elections be consolidated, as authorized by law; now, therefore, be it

16 RESOLVED, That pursuant to California Elections Code, Sections 10400 et seq., the
17 State of California General Election; the City and County of San Francisco Municipal Election;
18 the City and County of San Francisco Special Bond Election; the BART District Election; the
19 School Board Election; the City College Board Election; and the Peninsula Corridor Joint
20 Powers Board District Special Tax Election shall be consolidated; and, be it

21 FURTHER RESOLVED, That the voting precincts, polling places, and officers of the
22 elections set forth in this Resolution shall, in every case, be the same; that there shall be only
23 one set of election officers in each precinct, to wit, the election officers to be appointed by the
24 Director of Elections for each precinct; that all candidates, ballot measures and bond
25 proposals shall be set forth on the ballots provided for said election; that the elections shall be

1 held in all respects as though there were only one election, and that all returns shall be
2 canvassed by the Director of Elections as provided in the California Elections Code.
