NATURE OF THE CONTRACT (Please describe)  Contract No. 2020-20 is a new agreement providing proprietary equipment and services for the ATCS, in an amount not to exceed \$30,000,000 and an initial term of seven years with an option to extend two years. This contract does not authorize the expenditure of funds. Work will be contracted on a task-order basis, as each task's scope is defined and funding is identified independently. This agreement establishes the terms and conditions and labor rates for the work; the price, milestone dates, and scope of services will be negotiated in the individual task orders. Tasks procured under this agreement shall follow required Director, MTAB, and BOS approval thresholds for contract value.		

#### 7. COMMENTS

Due to the proprietary nature of Thales products implemented at SFMTA, any required system update, as well as, development of new features and functionalities, and successful integration with existing and planned systems will require Thales's involvement.
