5 **for \$90,000; the lawsuit was filed on September 12, 2019, in San Francisco Superior**  
6 **Court, Case No. CGC-19-579231; entitled Federal Insurance Company, as subrogee of**  
7 **CCT Enterprises LLC v. City and County of San Francisco, et al.; the lawsuit involves**  
8 **alleged property damage due to a ruptured water service lateral.**

10 Be it ordained by the People of the City and County of San Francisco:

11 Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby  
12 authorizes the City Attorney to settle the action entitled Federal Insurance Company, as  
13 subrogee of CCT Enterprises LLC v. City and County of San Francisco, et al., San Francisco  
14 Superior Court, Case No. CGC-19-579231 by the payment of \$90,000. The lawsuit involves  
15 alleged property damage due to a ruptured water service lateral.

16 Section 2. The above-named action was filed in San Francisco Superior Court on  
17 September 12, 2019, and the following parties were named in the lawsuit: plaintiff: Federal  
18 Insurance Company, as subrogee of CCT Enterprises LLC; defendant: City and County of  
19 San Francisco.
