12 WHEREAS, On July 10, 2018, by Resolution No. 18-0211, the Airport Commission
13 (Commission) awarded the Terminal 1 Food and Beverage Concession Lease 3 (Lease)
14 to Amy's Kitchen Restaurant Operating Company, LLC dba Amy's Drive Thru (Tenant);
15 and

16 WHEREAS, On January 15, 2019, by Resolution No. 024-19, the Board of
17 Supervisors approved the Lease; and

18 WHEREAS, On September 10, 2019, by Resolution No. 19-0194, the Commission
19 approved Amendment No. 1 to the Lease with Tenant to extend the base operating term of
20 the Lease by two years for a new expiration date of July 31, 2031, intended to improve the
21 financial health of the Lease by allowing for a longer development cost amortization
22 period; now, therefore, be it

23 RESOLVED, That the Board of Supervisors hereby approves Amendment No. 1 to
24 the Terminal 1 Food and Beverage Concession Lease 3 No. 18-0211 with Amy's Kitchen

1 Restaurant Operating Company, LLC, copies of which are contained in Board of
2 Supervisors' File No. 200204 ; and, be it

3 FURTHER RESOLVED, That within thirty (30) days of the Amendment No. 1 being
4 fully executed by all parties, the Airport Commission shall provide a copy of the final
5 Amendment No. 1 to the Clerk of the Board for inclusion into the official file.
