- The proposed project must meet these conditions and all applicable City Codes. In case of conflict, the more restrictive controls apply.

- 3. Minor modifications as determined by the Zoning Administrator may be permitted.

This Modification Decision and the recorded Notice of Special Restrictions for Case No. 2015-014040VAR shall be reproduced on the Index Sheet of the construction plans submitted with the Site or Building Permit Application for the Project. This Index Sheet of the construction plans shall reference the Variance Case Number.

The use of said property contrary to these special restrictions shall constitute a violation of the

Planning Code, and no release, modification or elimination of these restrictions shall be valid unless notice thereof is recorded on the Land Records by the Zoning Administrator of the City and County of San Francisco; except that in the event that the zoning standards above are modified so as to be less restrictive and the uses therein restricted are thereby permitted and in conformity with the provisions of the Planning Code, this document would no longer be in effect and would be null and void.
