2 O'Farrell and 48 Stockton Streets.]

3 **Motion approving the decision of the Department of Public Works to revoke a Minor**  
4 **Sidewalk Encroachment Permit for 77 O'Farrell and 48 Stockton Streets, Assessor**  
5 **Block No. 328, Lot No. 003, in connection with the Central Subway Project, and**  
6 **rejecting the appeal of Martin H. Orlick.**

8 WHEREAS, On January 23, 2007, the Department of Public Works issued Minor  
9 Sidewalk Encroachment Permit No. 06MSE-0181 to allow occupancy of the public right-of-  
10 way for a subsidewalk basement at 77 O'Farrell and 48 Stockton Streets, Assessor Block No.  
11 328, Lot No. 003; and,

12 WHEREAS, The Department of Public Works, in a letter dated November 16, 2009,  
13 revoked the Encroachment Permit in connection with the Central Subway project at the  
14 abovementioned address. Said letter is on file with the Clerk of the Board of Supervisors in  
15 File No. 091388 and is incorporated herein by reference; and,

16 WHEREAS, Martin H. Orlick filed a timely appeal of the decision of the Department of  
17 Public Works. Said appeal letter is on file with the Clerk of the Board of Supervisors in File  
18 No. 091388 and is incorporated herein by reference; and,

19 WHEREAS, The SFMTA Board of Directors adopted Resolution No. 08-150 on August  
20 19, 2008, approving the Central Subway Project, the CEQA Findings and Statement of  
21 Overriding Considerations for the Central Subway Final Supplemental Environmental Impact  
22 Report (SEIS/SEIR) and the Mitigation Monitoring and Reporting program. The SEIS/SEIR,  
23 CEQA Findings, background reports, and other documents in the administrative record  
24 associated with the SEIS/SEIR collectively are on file with the Secretary of the Planning  
25 Commission, Secretary of the MTA Board of Directors, and the Clerk of the Board in File Nos.
