10 Be it ordained by the People of the City and County of San Francisco:

12 Section 1. Chapter 10, Article XIII of the Administrative Code is hereby amended by  
13 adding Section 10.100-377, to read as follows:

15 **SEC. 10.100-377. WORKFORCE EDUCATION AND RECOVERY FUND.**

16 (a) Establishment of Fund. The Workforce Education and Recovery Fund (“the Fund”) is  
17 hereby established as a category four fund to provide financial support to City College of San  
18 Francisco (“City College”) for workforce and professional development programs; student support  
19 and wrap around services supporting student retention; and social justice, equity, lifelong learning,  
20 and enrichment classes.

21 (b) Sources of Monies. The Fund may receive any legally available monies appropriated for  
22 this purpose.

23 (c) Administration and Use of the Fund. The Department of Children, Youth, and Their  
24 Families (“the Department”) shall administer the Fund and, at the beginning of each fiscal year, shall  
25 use:

1                   (1) one-half of the monies in the Fund to support City College workforce and  
2 professional development programs, including but not limited to programs for health professionals,  
3 registered and vocational nursing, biotechnology, health education, aircraft maintenance, business,  
4 building trades and construction management, early childhood education, child development,  
5 emergency responders, custodial services, hospitality, culinary arts, digital media arts, photography,  
6 computer programming, computer networking, cybersecurity, information technology, and English as a  
7 Second Language;

8                   (2) one-quarter of the monies in the Fund to support City College student support  
9 services, classified staff support and coordinators, wrap-around services supporting student retention,  
10 student employment, and classified professional development; to support disadvantaged, low-income,  
11 immigrant, Lesbian Gay Bisexual Transgender Queer, women, disabled, and veteran students; and to  
12 meet students' basic needs, including but not limited to academic counseling and tutoring, childcare,  
13 rental assistance, and transportation assistance and subsidies like Clipper cards; and

14                   (3) one-quarter of the monies in the Fund to support City College social justice, equity,  
15 lifelong learning, and enrichment classes, including but not limited to Ethnic Studies, African American  
16 Studies, Latin/Latinx Studies, Asian American Studies, Women & Gender Studies, Philippine Studies,  
17 LGBTQ Studies, Older Adults, Art, Music, Physical Education, Adult Basic Education, and World  
18 Languages and Cultures.

19                   **(d) Expenditure Plan and Oversight.**

20                   (1) The Department shall request that City College submit an expenditure plan to the  
21 Department, the Mayor, and the Board of Supervisors each fiscal year, and the Department shall not  
22 expend any monies in the Fund in a fiscal year unless City College submits a plan in compliance with  
23 this subsection (d). The Department must receive the plan by no later than June 30 of each year  
24 regarding monies to be received from the Fund for the upcoming fiscal year, and (b) no later than  
25 December 31, 2020 regarding monies to be received from the Fund for Fiscal Year 2020-21. The plan

1 shall include a budget for the expenditures permitted under subsection (c), descriptions of programs  
2 and services, performance goals, target populations, hiring and recruitment plans for personnel, plans  
3 for matching or other additional funding, operating reserves, and any other matters that City College  
4 deems appropriate or the Department, the Mayor, or the Board of Supervisors requests.

5 \_\_\_\_\_ (2) To the extent consistent with the civil service provisions of the Charter, the  
6 Controller shall select an independent auditor to audit City College’s use of monies disbursed from the  
7 Fund and that independent auditor shall prepare an audit report no later than six months after the end  
8 of each fiscal year. The Controller shall promptly deliver each annual audit report to the Board of  
9 Supervisors and the Mayor.

10  
11 Section 2. Effective Date. This ordinance shall become effective 30 days after  
12 enactment. Enactment occurs when the Mayor signs the ordinance, the Mayor returns the  
13 ordinance unsigned or does not sign the ordinance within ten days of receiving it, or the Board  
14 of Supervisors overrides the Mayor’s veto of the ordinance.

## **LEGISLATIVE DIGEST**

[Administrative Code - Workforce Education and Recovery Fund]

### **Ordinance amending the Administrative Code to establish the Workforce Education and Recovery Fund.**

#### **Existing Law**

In 2016, by ordinance, the City established the San Francisco City College Financial Assistance Fund as a category four fund to provide financial assistance to students at City College of San Francisco (“City College”). The ordinance further provided that the Department of Children, Youth, and Their Families (“DCYF”) would administer the fund and use monies in the fund to make grants to reimburse City College for enrollment fees and other education-related financial support for students.

#### **Amendments to Current Law**

This ordinance would establish the Workforce Education and Recovery Fund (“the Fund”) as a category four fund to provide financial support to City College for workforce and professional development programs; student support and wrap around services supporting student retention; and social justice, equity, lifelong learning, and enrichment classes. This ordinance would require DCYF to administer the Fund and to use the monies as follows:

- (1) one-half of the monies in the Fund to support City College workforce and professional development programs;
- (2) one-quarter of the monies to support student support services, classified staff support, classified professional development, and to support disadvantaged students; and
- (3) one-quarter of the monies to support social justice, equity, lifelong learning, and enrichment classes.

This ordinance would require that City College submit an annual expenditure plan to DCYF, the Mayor, and the Board of Supervisors.

This ordinance would require that the Controller select an independent auditor to audit City College’s use of monies in the Fund and prepare an annual audit report for the Mayor and Board of Supervisors.
