9 Be it ordained by the People of the City and County of San Francisco:

10 Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby
11 authorizes the City Attorney to settle the action entitled Richard Denton v. City and County of
12 San Francisco, et al., San Francisco Superior Court, Case No. CGC 13-534508 by the
13 payment of \$400,000. The lawsuit involves an employment dispute.

14 Section 2. The above-named action was filed in San Francisco Superior Court on
15 September 26, 2013, and the following parties were named in the lawsuit: plaintiff: Richard
16 Denton; defendants: the City and County of San Francisco, Barbara Hale, John Doyle, and
17 Lori Mitchell.
