3 **Ordinance authorizing settlement of the lawsuit filed by Taulib Ikharo against the City**  
4 **and County of San Francisco for \$75,000; the lawsuit was filed on September 20, 2019,**  
5 **in U.S. District Court for the Northern District of California, Case No. 19-cv-04138 TSH;**  
6 **entitled Taulib Ikharo v. City and County of San Francisco, et al.; the lawsuit involves**  
7 **allegations of civil rights violations.**

9 Be it ordained by the People of the City and County of San Francisco:

10 Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby  
11 authorizes the City Attorney to settle the action entitled Taulib Ikharo v. City and County of  
12 San Francisco, et al., U.S. District Court for the Northern District of California, Case No. 19-  
13 cv-04138 TSH by the payment of \$75,000. The lawsuit involves alleged civil rights violations.

14 Section 2. The above-named action was filed in U.S. District Court for the Northern  
15 District of California on September 20, 2019, and the following parties were named in the  
16 lawsuit: Plaintiff Taulib Ikharo; Defendants City and County of San Francisco, Sheriff Vicky  
17 Hennessy, Deputy William James #1858, Deputy Nicholas Naranjo #1846, and Deputy  
18 Michael Mohn #1395.
