15	WHEREAS, In accordance with Governor Newsom's Executive Order No. N-33-20
16	declaring a State of Emergency regarding the COVID-19 outbreak and Mayor London N.
17	Breed's Proclamation declaring a Local Emergency issued on February 25, 2020,
18	including the guidance for gatherings issued by the San Francisco Department of Public
19	Health Officer, aggressive directives were issued to reduce the spread of COVID-19 and
20	on March 17, 2020, the Board of Supervisors authorized their Board and Committee
21	meetings to convene remotely, and will continue to do so until the local state of
22	emergency is over; and
23	WHEREAS, The Rules of Order, Section 4.2.1 also states that during holiday periods,
24	the application of specific days of the week described in the rules shall be revised by the Clerk
