[Guaranteed Income Advisory Group]

Ordinance amending the Administrative Code to establish the Guaranteed Income Advisory Group to advise the Board of Supervisors, the Mayor, and City departments regarding the establishment of a Guaranteed Income Pilot Program.

Existing Law

Currently, there is no City advisory body dedicated to providing advice regarding the establishment of a Guaranteed Income Pilot Program.

Amendments to Current Law

The proposed ordinance would create an 11-member advisory body called the Guaranteed Income Advisory Group ("Advisory Group"). The Board of Supervisors would appoint eight members, and the Treasurer, the Executive Director of the Human Rights Commission, and the Executive Director of the Human Services Agency would each appoint one member.

By no later than December 1, 2021, the Advisory Group would submit to the Board of Supervisors a final report with findings and recommendations regarding:

- Different paths to economic security, modeled on the principles of Guaranteed Income;
- Best practices in the administration and delivery of Guaranteed Income programs, and challenges in the implementation of such programs;
- How a Guaranteed Income program may be associated with reductions in poverty and violence (including gender-based violence, intimate partner violence, and community violence), and improvements in personal financial savings, school attendance, youth engagement with school and community programming, birth outcomes, health, and well-being:
- How a Guaranteed Income program affects work stability, economic security, consumer protections, and economic mobility;
- How a Guarantee Income program would impact children and families in San Francisco;
- The recommended components of a Guaranteed Income pilot program for 500-1,000 participants, in which each participant would be provided with a minimum of \$500/month to be used without restrictions.

Following the submission of its final report, the Advisory Group would advise on strategies to implement the recommendations contained in its report. The Advisory Group would terminate in two years, unless extended by ordinance adopted by the Board.

Background

This Legislative Digest reflects amendments made in the Rules Committee on December 8, 2020 to expand the number of Advisory Group members from nine to eleven, and to require the Advisory Group to advise on the potential impact of a Guaranteed Income program on families and children in San Francisco.

At our **Monday, November 16, 2020, meeting**, the Youth Commission voted unanimously to support the following motion:

To support BOS File No. 201263 - [Administrative Code - Guaranteed Income Advisory Group]

The Youth Commissioners voted to include the following recommendations and comments:

Recommendations:

- Ensure that the Advisory Board consider who qualifies for the Universal Basic Income (UBI) program it develops, specifically considering the undocumented community.
- In accordance with a resolution (<u>1920-AL-15</u>) passed by a former Youth Commissioner, create a board that directly engages with Community Based Organizations to study and report the impact on children, youth, and families.
- Remove language barring advisory group members from being compensated for their service, especially for members who have lived experience.
- Make seat 7 (tax collector) and seat 9 (HSA) ex officio (non-voting) members.
- Instead of one seat for seat 4, make it 3 more seats available specifically for people who have direct experience living in poverty.
- Add 2 additional seats for youth; 1 seat for TAY and 1 seat for a young person under the age of 18 (to be modeled after DCYF OAC youth seats).

Comments:

- Consider revisiting the compensation for community members who are giving their time to this group, as their lived experiences and service should be honored.
- The Youth Commission can support with outreach once this group is finalized.

Language establishing attendance requirements

Yes. Page 3, Lines 6-10, Section 5.47-3, entitled Organization and Term of Office," states "Any member who misses three regular meetings of the Advisory Group within a three-month period without the express approval of the Advisory Group at or before each missed meeting shall be deemed to have resigned from the Advisory Group ten days after the third unapproved absence. The Advisory Group shall inform the appointing authority and the Clerk of the Board of Supervisors of any such resignation."

Number of seats and qualifications

The Advisory Group shall consist of eleven voting members, appointed as follows:

Seat 5 shall be held by a person under the age of 24 at the time of appointment who has personally experienced poverty, appointed by the Board of Supervisors.

Seats 6, 7 and 8 shall each be held by a person with professional experience serving low-income individuals, families, or youth, and with training and expertise in social, racial, or gender equity, intersectional problem-solving, or cultural humility, appointed by the Board of Supervisors.

Seat 9 shall be held by an employee of the Office of the Treasurer and Tax Collector, appointed by the Treasurer.

Seat 10 shall be held by an employee of the San Francisco Human Rights Commission ("HRC"), appointed by the Executive Director of HRC.

Seat 11 shall be held by an employee of the Human Services Agency ("HSA"), appointed by the Executive Director of HSA.

Seats 1, 2, 3, 4, 5, 6, 7 and 8 may not be held by employees of the City and County of San Francisco.

Administering Department

The Office of the Treasurer and Tax Collector shall provide administrative and clerical support for the Advisory Group.

Reporting requirements

By no later than December 1, 2021, the Advisory Group shall submit to the Board of Supervisors and the Mayor a final report summarizing its research, findings, and recommendations on the topics set forth in subsection (a), and any additional findings and recommendations that the Advisory Group concludes advances its goals and fulfills its duties.

Sunset date

Unless the Board of Supervisors by ordinance extends the term of the Advisory Group, this Article XLVII shall expire by operation of law, and the Advisory Group shall terminate, two years after the effective date of the ordinance.
