

FEDERAL RELIEF



\$900 Billion COVID Relief Package

This deal includes over \$284 billion for first and second forgivable PPP loans, dedicated set-asides for very small businesses and lending through community-based lenders, and expanded PPP eligibility for 501(c)(6) nonprofits. Loan forgiveness process is simplified for borrowers with PPP loans of \$150,000 or less.

For workers

UI Extension • 11 weeks at \$300/week (an extension of all benefits)

- \$600 stimulus checks (for incomes under \$100k)
- \$25 billion rental assistance (residential)

For small businesses

\$325 billion in grants and loans for small businesses and nonprofits

- PPP \$284 billion
- EIDL \$20 billion

LOCAL RELIEF

For small businesses

Over \$24 million in loan and grant programs to support 1,230 small businesses and their employees.

- **\$2.5M** Small Business Resiliency Fund
- **\$12M** Hardship Emergency Loan Program (SF HELP)
- **\$3.8M** African-American Revolving Loan Fund
- \$3.2M Latino Small Business Fund
- **\$1M** Neighborhood Mini-Grants and Women's Mini-Grants
- **\$1.6M** SF Shines for Reopening

For workers

\$19.48 million to support approximately 32,500 impacted workers and their families.

- **\$600K** Immigrant Workers Fund
 - **\$4M** Right to Recover
- **\$4.88M** Family Relief Fund
 - **\$10M** Workers and Families First



AVAILABLE RESOURCES

Local

SF SHINES FOR REOPENING

Up to \$5k for small businesses to cover physical improvements that promote safe reopening, and can be used retroactively.

LATINO BUSINESS FUND

Up to \$50k for Latino-owned small businesses to cover payroll, rent, utilities, inventory, and other expenses.

SHARED SPACES EQUITY GRANTS

Up to \$5k for small businesses and groups that hold Shared Spaces permits.

State

CA REBUILDING FUND

Fixed interest loans up to \$100k.

COVID RELIEF GRANT

Grants up to \$25k to underserved small businesses and cultural institutions (expected to open early January).

Other relief

Commercial eviction moratorium, delivery fee commission cap, state and local tax and fee waivers/deferment, free supplies of PPE
