11	Francisco Latino Democratic Club, and co-sponsored by the Chicano Latino Caucus, the San
12	Francisco Democratic Party, the Rose Pak Democratic Club, California Assemblymembers
13	Chiu (AD-17) and Gonzalez (AD-80), and a number of other individuals and organizations;
14	and
15	WHEREAS, The March 2019 Resolution made it the policy of the California Democratic
16	Party to expand eligibility for all Californians to register with the California Democratic Party,
17	regardless of immigration status; and
18	WHEREAS, The California Democratic Party is governed by By-Laws and Rules of the
19	California Democratic Party (the "Bylaws"), which are amended from time to time; and
20	WHEREAS, The governing body of the California Democratic Party is the Democratic
21	State Central Committee, and members may either be appointed pursuant to Article II,
22	Section 3 of the Bylaws, or, in pertinent part, elected by Assembly District Election Meetings
23	pursuant to the rules and procedures set forth in Article VI of the Bylaws; and
24	WHEREAS, Article II, Section 1d of the Bylaws allows California residents, including
25	non-citizen residents, to serve on the Democratic State Central Committee if they are

ineligible to register as Democrats "but have expressed an intent to register as a member of
 the California Democratic Party upon becoming eligible to do so;" and

WHEREAS, While non-citizens may serve on the Democratic State Central Committee
as appointees, they are still ineligible to participate in Assembly District Elections, wherein
participation requires formal registration with the California Democratic Party; and

6 WHEREAS, Following the adoption of the March 2019 Resolution, the California
7 Democratic Party had numerous opportunities to amend its Bylaws through the Party's Rules
8 Committee to expand eligibility for non-citizens to either register with the Party or to expand
9 eligibility for Assembly District Elections to non-citizens who expressed an intent to register as
10 a member of the Party upon becoming eligible to do so; and

WHEREAS, In advance of the forthcoming Assembly District Elections, advocates
 including those who sponsored the March 2019 Resolution have repeatedly requested that
 the Party Bylaws be amended to allow non-citizens to participate in Assembly District
 Elections; and

WHEREAS, The Party through its Rules Committee has failed to follow through on the commitments set forth in the March 2019 Resolution in a timely manner, thereby disqualifying from participation non-citizens who are ineligible to register with the Democratic Party but who have nevertheless expressed clear intent to register once they are eligible to do so; and

WHEREAS, By rendering non-citizens ineligible to participate in Assembly District
 Elections, the California Democratic Party has sent a harmful message to more than 5 million
 California residents at a time when their inclusion will only strengthen the California

23 WHEREAS, As the United States government has used the politics of fear to silence 24 the voices of immigrants by directly threatening the safety, security, and livelihood of 25 immigrants in California and the United States, there is no more appropriate time to facilitate, encourage and invite participation by non-citizens in critical policy decisions that directly
