9	Be it ordained by the People of the City and County of San Francisco:
10	Section 1. The San Francisco Administrative Code is hereby amended by amending
11	Section 10B.1, to read as follows:
12	SEC. 10B.1. REQUEST FOR POLICE SERVICES.
13	Any person, corporation, firm or organization desiring additional personnel, equipment
14	or materials of the San Francisco Police Department, for law enforcement purposes within the
15	City and County of San Francisco, may request the Chief of the San Francisco Police
16	Department to provide such personnel to perform such services. If the Chief of Police
17	approves the request, he or she may detail such personnel for such services in the number he
18	or she determines to be necessary to perform the services. If the Police Department determines
19	that the requested police services will require dispatch services from the Department of Emergency
20	Management, the Chief of Police or designee shall notify the Executive Director of the Department of
21	Emergency Management, and the Executive Director may detail such personnel for such services in the
22	number he or she determines to be necessary to perform the dispatch services.

Section 2. The San Francisco Administrative Code is hereby amended by amending
 Section 10B.2, to read as follows:

SEC. 10B.2. PAYMENT FOR SERVICES.

4 (a) Except as provided in Subsection (f), below, the person, corporation, firm or 5 organization desiring such services shall pay to the pPolice dD epartment such sums of money 6 as may be necessary to pay for the additional services, *including any dispatch services provided* 7 by the Department of Emergency Management. The payment shall include a component for Police 8 Department services, be computed based upon the rate paid or payable to those uniformed 9 officers of the Police Department actually performing services at the time they are to perform 10 such additional duties, and the cost of additional equipment and materials expended, together 11 with an administrative overhead charge to cover the proportionate percentage of the *Police* 12 Department's administrative costs that are attributable in the Department's reasonable 13 discretion to the work performed pursuant to the request. The payment shall also include a 14 component for any dispatch services provided by the Department of Emergency Management, which 15 shall be computed by the Department of Emergency Management based on the rate paid or payable to 16 the dispatch personnel actually performing services at the time they are to perform such additional 17 duties. 18 No person, corporation, firm or organization that contracts with the Police Department for additional services that are: 1) of the type normally provided by police officers on patrol in 19 20 the designated area; and 2) to be provided at least four days per week, each week, for a 21 period in excess of one year, shall be required to pay an administrative overhead charge, 22 unless such additional services are provided in conjunction with a City permit or license, or 23 are otherwise necessary to mitigate a negative impact created by the activity of the person, 24 corporation, firm or organization contracting for the additional services.

1 (b) The Police Department shall provide an estimate of the payment for such services, 2 including an estimate from the Department of Emergency Management for any dispatch services, to 3 the person, corporation, firm or organization desiring the service within a reasonable time prior 4 to the date service is to be rendered. The person, corporation, firm or organization shall 5 deposit the amount of estimated funds with the Police Department prior to the time that the 6 Police Department renders the requested service. The Police Department may waive the 7 deposit requirement if services are requested for 30 days or more, or if Department 8 reasonably believes that a waiver is justified.

9 (c) Within a reasonable time after the services are rendered, the Chief of Police shall 10 determine the amount of payment due. The amount due shall be based on actual services 11 performed by the Police Department and any dispatch services by the Department of Emergency 12 *Management.* If the deposit pursuant to Subsection (b) hereof is insufficient to cover the cost of 13 *police and dispatch* services, the Chief of Police shall notify the person, corporation, firm or 14 organization that requested the services by United States mail to the address listed on the 15 request for such services and that party shall have ten days to pay the balance. If the amount 16 deposited exceeds the actual costs, the Chief of Police shall authorize a refund of the excess 17 to the applicant at the address shown on the application.

(d) The Police Department shall deposit with the Treasurer such sums as received in
a special account designated public facilities overtime account; provided, however, that the
amount representing <u>Police Department</u> administrative overhead shall be deposited to the
general fund unappropriated balance of funds, <u>and the amount for the Department of Emergency</u>
<u>Management's dispatch services shall be transferred to the Department of Emergency Management</u>.
(e) The person, corporation, firm or organization shall indemnify, hold harmless and

defend said City and County of San Francisco, the San Francisco Police Department, *the* 

25 <u>Department of Emergency Management</u>, and all the <u>City and County</u> officers, agents and

1 employees of either, from and against all liability, judgments or claims for personal or bodily 2 injuries, false arrest and false imprisonment caused by or purportedly caused by such 3 personnel in the rendering of such services. 4 (f) The City shall not waive payment for additional police or dispatch services pursuant 5 to this Chapter except by ordinance of the Board of Supervisors. 6 7 Section 3. The San Francisco Administrative Code is hereby amended by amending 8 Section 10B.3, to read as follows: SEC. 10B.3. RATES OF PAY. 9 10 For services performed in excess of the basic week, police department members shall be compensated on the basis of time and one-half in accordance with the ratio which said 11 12 excess service bears to the basic week of service and the annual compensation provided 13 therefor in Section A8.451 of the City Charter and applicable memoranda of understanding. 14 For services performed in excess of the basic week, Department of Emergency Management 15 personnel shall be compensated on the basis of time and one-half in accordance with the ratio which 16 said excess service bears to the basic week of service and the annual compensation provided therefor in 17 applicable memoranda of understanding. 18 Section 4. The San Francisco Administrative Code is hereby amended by amending 19 20 Section 10B.4, to read as follows: 21 SEC. 10B.4. MINIMUM ASSIGNMENT. Requested services from the Police Department shall be compensated upon the basis of 22 23 four hours per employee minimum per assignment. 24
