	number of managerial, administrative and executive level positions within the San Francisco
14	court system; and
15	WHEREAS, Gordon Park Li held the position of Chief Deputy where he was
16	responsible for overseeing the operations of the Court's Administrative, Civil/Small Claims,
17	Criminal and Traffic Divisions from1985 to 1989; and
18	WHEREAS, Gordon Park Li was appointed to the position of Clerk-Administrator for the
19	San Francisco Municipal Court in 1989; and
20	WHEREAS, Gordon Park Li, upon unification of the San Francisco trial courts in
21	December 1998 was appointed to the position of Assistant Chief Executive Officer and to the
22	position of Chief Executive Officer in July 2000; and

1	WHEREAS, As Chief Executive Officer, Gordon Park-Li was responsible for all non-
2	judicial functions of the San Francisco Superior Court and oversaw a staff of 600, four court
3	facilities and a budget of \$100 million; and

5	implementation of several programs, which were developed in response to San Francisco's
6	on-going jail overcrowding problem including the establishment of San Francisco's first Bail
7	Commissioner position, a Supervised Pre-trial Release Program and San Francisco's drug
8	court in May of 1995; and
9	WHEREAS, Gordon Park-Li has served as President of the California Court
10	Association (CCA), is a founding member and past Treasurer of the California Association of
11	Drug Court Professionals (CADCP) and a member of the National Association for Court
12	Management (NACM); now, therefore, be it
13	RESOLVED, That the San Francisco Board of Supervisors commends Mr. Gordon
14	Park Li for his 37 years of dedicated service to the San Francisco Superior Court; and, be it
15	FURTHER RESOLVED, That the San Francisco Board of Supervisors wishes Mr.
