3 **Resolution congratulating Mr. Gordon Park Li, on his outstanding career and thanking**
4 **him for his exceptional service to the City of County of San Francisco over the past 37**
5 **years and declaring March 23rd, 2010 as Gordon Park Li Day in the City and County of**
6 **San Francisco.**

8 WHEREAS, Gordon Park Li graduated from City College of San Francisco in 1970 with
9 a degree in Business Administration; and

10 WHEREAS, Gordon Park Li began his career with the San Francisco Municipal Court
11 in 1972 as a Deputy Clerk I; and

12 WHEREAS, Over the course of his 37 years with the Court, Mr. Park-Li has attained a
13 number of managerial, administrative and executive level positions within the San Francisco
14 court system; and

15 WHEREAS, Gordon Park Li held the position of Chief Deputy where he was
16 responsible for overseeing the operations of the Court's Administrative, Civil/Small Claims,
17 Criminal and Traffic Divisions from 1985 to 1989; and

18 WHEREAS, Gordon Park Li was appointed to the position of Clerk-Administrator for the
19 San Francisco Municipal Court in 1989; and

20 WHEREAS, Gordon Park Li, upon unification of the San Francisco trial courts in
21 December 1998 was appointed to the position of Assistant Chief Executive Officer and to the
22 position of Chief Executive Officer in July 2000; and

23 WHEREAS, As Chief Executive Officer, Gordon Park-Li was responsible for all non-
24 judicial functions of the San Francisco Superior Court and oversaw a staff of 600, four court
25 facilities and a budget of \$100 million; and

1 WHEREAS, Gordon Park-Li was a major participant in the planning and
2 implementation of several programs, which were developed in response to San Francisco's
3 on-going jail overcrowding problem including the establishment of San Francisco's first Bail
4 Commissioner position, a Supervised Pre-trial Release Program and San Francisco's drug
5 court in May of 1995; and

6 WHEREAS, Gordon Park-Li has served as President of the California Court
7 Association (CCA), is a founding member and past Treasurer of the California Association of
8 Drug Court Professionals (CADCP) and a member of the National Association for Court
9 Management (NACM); now, therefore, be it

10 RESOLVED, That the San Francisco Board of Supervisors commends Mr. Gordon
11 Park Li for his 37 years of dedicated service to the San Francisco Superior Court ; and, be it

12 FURTHER RESOLVED, That the San Francisco Board of Supervisors wishes Mr.
13 Gordon park Li the best in all of his future endeavors; and, be it

14 FURTHER RESOLVED, That in recognition of Mr. Gordon Park Li's outstanding and
15 distinguished career that the San Francisco Board of Supervisors officially declare March 23rd,
16 2010 as Gordon Park Li Day in the City and County of San Francisco.
