The text is listed:

The Right to Recover program provides \$1,285.60 dollars to any San Francisco resident that tests positive for COVID 19 and does not have the resources to safely isolate during the infectious period. So far, the program has provided \$4.5 million dollars to over 3,500 people but has had to pause several times because of a lack of funding. Most of the funding for Right to Recover has come from philanthropic funds through the GIVE2SF program. Recently, the Mayor has allowed the use of funds from Health Care Security Ordinance Medical Reimbursement Accounts for those workers who have worked for employers that have contributed to those accounts. These additional funds should provide security to up to 10-15% of residents eligible for this assistance program.

I am calling a hearing on the Right to Recover program to discuss the following topics:

How many times has the program paused because of lack of funds and how many eligible individuals have failed to receive this economic assistance since the program began?

How much money is currently available to assist COVID 19 positive residents in the program?  
How much additional funding would be needed to fully fund the program throughout the duration of the pandemic (estimated)?

What has been the impact of the program on the individuals who received funding and public health at large?
