3	Resolution celebrating 2021 as Year of the Ox, and recognizing February 12, 2021, as
4	the start of Lunar New Year 4719 in the City and County of San Francisco.
5	
6	WHEREAS, 2021 marks Lunar year 4719, the Year of the Ox, which begins on Friday,
7	February 12, 2021; and
8	WHEREAS, Celebrations for the Lunar New Year begin with the New Moon on the first
9	day of the new year and end on the full moon 15 days later; and
10	WHEREAS, The first Chinese New Year Parade took place in San Francisco's
11	Chinatown in 1885 with a 15-day celebration and a block-long golden dragon preceded by the
12	red pearl of potentiality; and
13	WHEREAS, In an effort to celebrate Chinatown and draw visitors to Chinese-owned
14	businesses, the Chinese Chamber of Commerce transformed the Chinese New Year
15	celebration into a Street Carnival at Portsmouth Square in 1953; and
16	WHEREAS, To further its efforts to promote Chinatown, the Chinese Chamber of
17	Commerce launched the first Miss Chinatown, U.S.A. beauty pageant in 1958 as part of the
18	New Year festivities; and
19	WHEREAS, The Chinese New Year parade draws larger crowd each year with
20	increase of marching units and floats, and that to date, San Francisco Chinese New Year
21	parade is the largest parade celebrating Chinese New Year in the United States; and,
22	WHEREAS, The celebration of Chinese New Year in San Francisco has become a
23	cultural significance and its grand parade is now a recognized civic pride event of our city; and
24	WHEREAS, The annual Chinese New Year parade and almost month-long festivities
25	has provided an economic boost to our local economy beyond Chinatown; and

1	WHEREAS, The Lunar New Year may be known as Chinese New Year, but it is also
2	celebrated as Solnal in Korean communities, with the Tet Festival by the Vietnamese, and as
3	Losar in Tibet; and
4	WHEREAS, The Lunar New Year, also known as the Spring Festival, is a significant
5	holiday for Asian families to gather together, honor their ancestors, welcome the New Year
6	with hopes of prosperity and good health, and celebrate traditions and traditional foods; and
7	WHEREAS, During the COVID-19 pandemic, Lunar New Year themes of family, health
8	and prosperity, and renewal are especially important, but it is critical that families celebrate in
9	new ways in order to protect the most vulnerable in our communities; and
10	WHEREAS, Due to COVID-19 health orders, all long standing of Lunar New Year
11	celebrations and festivities have been impacted and cancelled in 2021, the Year of the Ox;
12	now, therefore, be it
13	RESOLVED, That the Board of Supervisors of the City and County of San Francisco
14	bids farewell to 2020, Year of the Rat, and commits to celebrate Asian families and Lunar
15	New Year Festivities in accordance of the City's public health orders; and be it
16	FURTHER RESOLVED, That the Board of Supervisors of the City and County of San
17	Francisco wishes all families good luck, prosperity, and continued good health in the Year of
18	the Ox; and be it
19	FURTHER RESOLVED, That the Board of Supervisors of the City and County of San
20	Francisco celebrates 2021 as the Year of the Ox and recognizes February 12, 2021, as the
21	start of Lunar New Year 4719.
