18	WHEREAS, Public Works, in a decision dated December 7, 2020, disapproved a
19	Tentative Map for a six unit condominium conversion at 424, 426, 428, 430, 432, and 434
20	Francisco Street, Assessor's Parcel Block No. 0041, Lot No. 010; and
21	WHEREAS, Said determination is on file with the Clerk of the Board of Supervisors in

5	consider the appeal of Public Works' decision regarding the Tentative Map filed by Appellant;

8	appeal letter, and the other written records before the Board of Supervisors, and heard
9	testimony and received public comment regarding the subject Tentative Map; now, therefore,
10	be it

12	concerning the Tentative Map for the project at Assessor's Parcel Block No. 0041, Lot No.
13	010 and hereby disapproves said Map, subject to the Board of Supervisors' adoption of
