Motion appointing Jason Oringer and Sarah Church, terms ending December 17, 2011, to the Sweatfree Procurement Advisory Group, residency requirement waived.

MOVED, That the Board of Supervisors of the City and County of San Francisco does hereby appoint the hereinafter designated persons to serve as members of the Sweatfree Procurement Advisory Group, pursuant to the provisions of Board of Supervisors Ordinance No. 223-05, for the terms specified:

Jason Oringer, seat 1, succeeding himself, term expired, must have significant experience representing employees in labor matter, for the unexpired portion of a two-year term ending December 17, 2011.

Sarah Church (residency requirement waived), seat 3, succeeding herself, term expired, must have significant experience as an advocate for human rights or the poor, for the unexpired portion of a two-year term ending December 17, 2011.

FURTHER MOVED, That the Board of Supervisors makes the following findings:

- 1. The membership of the Sweatfree Procurement Advisory Group has a goal to be representative of the diversity of the City and County of San Francisco.
- 2. Applicant Sarah Church, who is not a resident of San Francisco, is a person with experience that uniquely qualifies her to serve on the Sweatfree Procurement Advisory Group.
- 3. The Sweatfree Procurement Advisory Group has attempted to fill the position, for which Sarah Church was nominated, with an individual who is a City resident and who has the specific experience, skills, and qualifications, but has been unable to

After exercising due diligence, the Board of Supervisors concludes that there is no other possible representative, who is a resident of San Francisco and who has the specific experience, skills, or qualifications possessed by this applicant, and who is willing to serve on the Sweatfree Procurement Advisory Group at this time; and, be it

FURTHER MOVED, That the Board of Supervisors waives the residency requirement for Sarah Chuch, as allowed in cases where no qualified City resident, willing to serve, can be found, pursuant to Section 4.101 of the City Charter that requires person(s) appointed to boards, commissions, and advisory bodies established by legislative act of the Board of Supervisors to be resident(s) of the City and County of San Francisco.
