Dear Suki:

I'm enclosing a copy of my 1996 Curriculum Vitae. I'm afraid all of the resumes on my computer have de-formatted since I inputted them in Word 5.1; and it would take me at least two days to correct or re-input them. So rather than do that, as you suggested in the interest of timeliness, I will just enclose a copy of my 1996 resume and update it in this letter.

My last presentation to professional and practitioner groups was in 2004. With Marie Jobling, then Executive Director of Planning for Elders in the Central City, now PECC, I presented at the meetings of the American Society on Aging, on our program Senior Survival School. This program of PECC provides information about community and government services for the elderly, and about how to obtain them and work with bureaucracies. PECC still has this program, presented in many different languages and targeted, not only to the elderly, but to other groups, such as the homeless and the GLBT community.

Since 1996, I have served on the Board of PECC and The Public Authority for In Home Support Services. I left the PECC Board about 2006 and the Public Authority in 2000. I currently (since 2008) serve on the board of the Community Living Campaign, which develops friendship circles for isolated elders and disabled people. I also serve on the Advisory Committee to San Francisco Village, which combines volunteer and professional services to keep older people in their homes, based on a model developed in Boston and being replicated nationwide. I am active in the Village, currently working on relationships with hospital discharge planners around transitional care. For example: often patients are discharged to home when the hospital can no longer do anything for them medically. This happens even when the older person needs services at home, and none have been arranged before discharge. It happened several times with my mother when I was taking care of her, and almost happened to my father as well, at several different hospitals. Transitional care would certainly be an interest of mine if I were to serve on the Advisory Council to the Aging and Adult Services Commission.

I also have experience working on evaluating Administration on Aging (AoA) programs. In 1994 I worked on a study to evaluate the State Long Term Care Ombudsmen programs of the Older Americans Act and on an AIDS/Adult Day Health Evaluation for the State of California. Both the original evaluation of On Lok (now Lifeways) and a day program at the Jewish Home for the Aged were originally Administration on Aging grants. Additionally, I worked on an AOA grant that examined information and referral services for the elderly in need of mental health services. These experiences are presented under Research in my work history and under Selected Community Service and Outreach.

I would be honored to serve on the Advisory Council to the Aging and Adult Services Commission, if I am nominated.

Again, my apologies to you for having you read such a long academic Curriculum Vitae.

Board Qualifications:

The Advisory Council is not to exceed 22 members (voting members), 11 of whom shall be appointed by the Board of Supervisors. The composition of the other members are as follows: 11 members appointed by the Commission on the Aging. More than 50% of the members of each group of 11 members shall be persons who are 60 years of age or older. The Council shall be representative of the geographic and ethnic populations of the City and County of San Francisco by districts determined by the Commission. The council shall include service providers, older persons with the greatest socio and economic need, consumers, and others specified by federal regulation.

The Advisory Council members shall be appointed to serve two year terms. When vacancies occur due to resignation or other causes, they shall be filled by the appointment of a person to fill the unexpired portion of the term by the Commission or corresponding Supervisor.

The Advisory Council shall advise the Commission on the Aging on all maters relating to the development and administration of its area plan and the operations conducted thereunder, including needs assessment, priorities, programs, and budgets, and such other matters relating to the well-being of all senior citizens 60 years of age and older within the scope and spirit of Federal, State and local regulations, laws and ordinances. The Advisory Council member shall be responsible for representing the needs and concerns of all senior citizens in the City and County of San Francisco, duties of which are outlined in the Bylaws.
