23 assigned to the Office by State law, by ordinance, or by the City Administrator provided that those
24 duties are consistent with the Office’s duties under State law and are otherwise permitted under local
25 law.

1 **(b) Appointment and Removal of Chief Medical Examiner and Executive Director.** The
2 City Administrator, with the concurrence of the Mayor, shall appoint and may remove a Chief
3 Medical Examiner who shall meet the qualifications for Chief Medical Examiner as provided
4 by ~~the~~ State law. The City Administrator also shall appoint and may remove an Executive Director. The
5 Executive Director shall not be required to meet the qualifications of a Chief Medical Examiner.

Section 2. Chapter 1 of Article III of the Campaign and Governmental Conduct Code is hereby amended by revising Section 3.1-251, to read as follows:

SEC. 3.1-251. GENERAL SERVICES AGENCY – CITY ADMINISTRATOR.

(a) **Disclosure Category 2.** Persons in this category shall disclose all interests in real property.

(b) **Disclosure Category 3.** Persons in this category shall disclose all investments and business positions in business entities, interests in real property, and income from any source that is subject to the regulatory, permitting, or licensing authority of the General Services Agency.

(c) **Disclosure Category 4.** Persons in this category shall disclose all investments and business positions in business entities and income from any source which provides, or contracts with the City and County of San Francisco and its Purchasing Department to provide, or has provided within the last two years, commodities or services to the City and County of San Francisco.

(d) **Disclosure Category 5.** Persons in this category shall disclose all investments and business positions in business entities and income from any source which provides, or contracts with the City and County of San Francisco to provide, or has provided within the last two years, commodities or services to either the Division of the Purchasing Department to which the person is assigned or the Department (other than the Purchasing Department) to which the person is assigned.

[Administrative, Campaign and Governmental Conduct Codes - Office of the Chief Medical Examiner]

Ordinance amending the Administrative Code and Campaign and Governmental Conduct Code to establish the position of Executive Director of the Office of Chief Medical Examiner, and to establish a division of responsibilities in that Office between the Executive Director and the Chief Medical Examiner.

Existing Law

The Office of the Chief Medical Examiner is responsible for providing death investigative services, including the investigation and certification of a variety of deaths of legal or public health interest. The Chief Medical Examiner is the head of the Office, and carries out duties under State law that must be performed by a county coroner or medical examiner. The Chief Medical Examiner is appointed by the City Administrator with concurrence of the Mayor, and may be removed by the City Administrator with the concurrence of the Mayor. The Office currently has approximately 39 employee positions, including four Assistant Medical Examiners.

Amendments to Current Law

The proposed ordinance would create a new position of Executive Director of the Office of Chief Medical Examiner. The City Administrator would have authority to appoint and remove the Executive Director without concurrence of the Mayor. The ordinance would not change the process for appointing or removing the Chief Medical Examiner.

The Chief Medical Examiner would continue to appoint and supervise the work and performance of all assistant or deputy medical examiners in the Office, and would continue to be responsible for making all final decisions assigned to a medical examiner or coroner under State law. The Executive Director would have all the other responsibilities of a department head for the office, including administrative supervision of all employees including the Chief Medical Examiner, and authority to appoint all employees other than assistant or deputy medical examiners. The ordinance would also authorize the City Administrator to assign additional duties to the Executive Director.

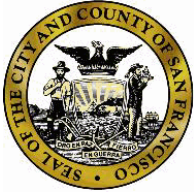



19 responsibilities of the Executive Director set forth in this Section 2A.250 on an interim basis until the
20 City Administrator appoints an Executive Director.

21 **(e)** The Office ~~Department~~ shall include such other officers and employees as are
22 authorized pursuant to the budgetary and fiscal provisions of the Charter.

23 **(b) Duties and Functions.** ~~The Office of the Chief Medical Examiner Department shall be~~
24 ~~responsible for the duties of the Medical Examiner as provided by state law, and such other duties and~~

Section 2. Chapter 1 of Article III of the Campaign and Governmental Conduct Code is hereby amended by revising Section 3.1-251, to read as follows:

SEC. 3.1-251. GENERAL SERVICES AGENCY – CITY ADMINISTRATOR.

(a) **Disclosure Category 2.** Persons in this category shall disclose all interests in real property.

(b) **Disclosure Category 3.** Persons in this category shall disclose all investments and business positions in business entities, interests in real property, and income from any source that is subject to the regulatory, permitting, or licensing authority of the General Services Agency.

(c) **Disclosure Category 4.** Persons in this category shall disclose all investments and business positions in business entities and income from any source which provides, or contracts with the City and County of San Francisco and its Purchasing Department to provide, or has provided within the last two years, commodities or services to the City and County of San Francisco.

(d) **Disclosure Category 5.** Persons in this category shall disclose all investments and business positions in business entities and income from any source which provides, or contracts with the City and County of San Francisco to provide, or has provided within the last two years, commodities or services to either the Division of the Purchasing Department to which the person is assigned or the Department (other than the Purchasing Department) to which the person is assigned.

7 Section 3. Effective Date. This ordinance shall become effective 30 days after
8 enactment. Enactment occurs when the Mayor signs the ordinance, the Mayor returns the
9 ordinance unsigned or does not sign the ordinance within ten days of receiving it, or the Board
10 of Supervisors overrides the Mayor's veto of the ordinance.

12 Section 4. Scope of Ordinance. In enacting this ordinance, the Board of Supervisors
13 intends to amend only those words, phrases, paragraphs, subsections, sections, articles,
14 numbers, punctuation marks, charts, diagrams, or any other constituent parts of the Municipal
15 Code that are explicitly shown in this ordinance as additions, deletions, Board amendment
16 additions, and Board amendment deletions in accordance with the "Note" that appears under
17 the official title of the ordinance.
