[Prohibiting Lying on Public Sidewalks]

NOTE:

Ordinance amending San Francisco Police Code by adding Section 168 to prohibit lying on a public sidewalk.

Be it ordained by the People of the City and County of San Francisco:

Section 1. The San Francisco Police Code is hereby amended by adding Section 168 to read as follows:

## SEC 168: PROHIBITING LYING ON PUBLIC SIDEWALKS.

(a) **Definitions.** For the purposes of this Section, lying shall be defined as making a false statement with deliberate intent to deceive.

discourse on public sidewalks is essential not only for a well-informed citizenry but also to maintain public safety and the encouragement of a vital social fabric in neighborhoods throughout the City.

(b) Findings. The people of the City and County of San Francisco find that maintaining honest

Persons who are lying also deter residents and visitors from engaging in social discourse, which deters

visitors and residents from using the sidewalks in their neighborhoods. Lying not only affects the way

people relate to one another, it also can negatively impact the local economy and public safety. This

behavior causes a cycle of decline as residents and tourists go elsewhere to meet, shop, dine, and

residents become intimidated from using the public sidewalks in their own neighborhoods. The

prohibition applies Citywide in order to prevent the displacement of lying from one district or

neighborhood to another.

The prohibition against lying on sidewalks leaves intact the individual's right to speak, protest or engage in other lawful activity on any sidewalk consistent with any City permitting requirements.

The prohibition applies only to sidewalks.

- (c) Prohibition. In the City and County of San Francisco, it is unlawful to be lying on a public sidewalk.
- (d) Warning. No person shall be cited under this Section unless the person engages in conduct prohibited by this Section after having been notified by a peace officer that the conduct violates this Section.

## (e) Penalties

- 1. First Offense. Any person violating any provision of this Section shall be guilty of an infraction. Upon conviction, the violator shall be punished by a fine of not less than \$50 or more than \$100 and/or community service, for each provision violated.
- 2. Subsequent Offenses. Any person violating any provision of this Section within 24 hours after violating and being cited for a violation of this Section shall be guilty of a misdemeanor and shall be punished by a fine of not less than \$300 and not more than \$500, and/or community service, for each provision violated, or by imprisonment in the County Jail for a period of not more than ten (10) days, or by both such fine and imprisonment. Any person violating any provision of this Section within 120 days after the date of conviction of a violation this Section shall be guilty of a misdemeanor, and shall be punished by a fine of not less than \$400 and not more than \$500, and/or community service, for each provision violated, or by imprisonment in the County Jail for a period of not more than thirty (30) days, or by both such fine and imprisonment.
- (f) Reporting. One year after the effective date of this ordinance, and every two years thereafter, the Police Department shall make a written report to the Mayor and the Board of Supervisors that evaluates the effect of enforcement of this ordinance on the City's neighborhoods.

(g) Severability. If any subsection, sentence, clause, phrase, or word of this Section be for any reason declared unconstitutional or invalid or ineffective by any court of competent jurisdiction, such decision shall not affect the validity or the effectiveness of the remaining portions of this Section or any part thereof.
