11	Be it ordained by the People of the City and County of San Francisco:

13	Section 1. Findings.		
14	(a) The Planning Department has determined that the actions contemplated in this		
15	ordinance comply with the California Environmental Quality Act (California Public		
16	Resources Code Sections 21000 et seq.). Said determination is on file with the Clerk of the		
17	Board of Supervisors in File No. 210346 and is incorporated herein by reference. The		
18	Board affirms this determination.		
19	(b) On April 21, 2021, the Building Inspection Commission considered this ordinance at		
20	a duly noticed public hearing pursuant to Charter Section D3.750-5.

22	Section 2. The Housing Code is hereby amended by revising Section 507, to read as		
23	follows:		
24	SEC. 507. COOKING FACILITIES.		
25	(a) Community kitchens.		

1	(1) General. Community kitchens provided for the use of occupants of guest
2	rooms shall comply with this section and shall not be removed but may be replaced.
3	* * * *
4	
5	Section 3. Effective Date. This ordinance shall become effective 30 days after
6	enactment. Enactment occurs when the Mayor signs the ordinance, the Mayor returns the
7	ordinance unsigned or does not sign the ordinance within ten days of receiving it, or the Board
8	of Supervisors overrides the Mayor's veto of the ordinance.
9	
10	Section 4. Scope of Ordinance. In enacting this ordinance, the Board of Supervisors
11	intends to amend only those words, phrases, paragraphs, subsections, sections, articles,
12	numbers, punctuation marks, charts, diagrams, or any other constituent parts of the Municipal
13	Code that are explicitly shown in this ordinance as additions, deletions, Board amendment
14	additions, and Board amendment deletions in accordance with the "Note" that appears under
15	the official title of the ordinance.

LEGISLATIVE DIGEST

[Housing Code - Community Kitchens]

Ordinance amending the Housing Code to prohibit removal of existing community kitchens in group housing; and affirming the Planning Department's determination under the California Environmental Quality Act.

Existing Law

Section 507 of the San Francisco Housing Code requires that community kitchens, if provided to the occupants of a building, must meet certain size requirements based on the number of guest rooms the community kitchens serve. The provisions do not explicitly prohibit removal of existing community kitchens currently serving occupants of guest rooms.

Amendments to Current Law

The Proposed Legislation would explicitly prohibit the removal of existing community kitchens serving occupants of guest rooms in group housing, but would allow replacement or remodel of existing community kitchens.

Background Information

The City's existing stock of group housing contains buildings with community kitchens, limited in-room kitchens, and somev without any kitchen facilities. The Proposed Legislation preserves the option to construct or otherwise establish new group housing without providing community kitchens. But where community kitchens have been established and relied upon by occupants of guest rooms, the Proposed Legislation would confirm that there is no option to remove those kitchens amenities without replacement.
