1	[Recognizing the One-Year Anniversary of Unidos En Salud]
2	
3	Resolution recognizing the one-year anniversary of Unidos En Salud, a partnership
4	between the University of California San Francisco and the Latino Task Force on
5	COVID-19, and expressing gratitude for lifesaving service to the people of San
6	Francisco.
7	
8	WHEREAS, On Monday, March 11, 2020, the World Health Organization declared
9	COVID-19 a global pandemic, unleashing death, uncertainly and bringing the global economy,
10	to a halt, which disproportionally impacted poor and underserved people all over worked, and
11	San Francisco was no exception; and
12	WHEREAS, Large numbers of immigrant and Latinx people work in essential industries
13	such as food cultivation and production, in retail selling essential goods like food and
14	hardware supplies, and in transportation, and were unable to shelter in place, increasing odds
15	of exposure; and
16	WHEREAS, From the beginning of the pandemic, the Mission District, a historically
17	Latinx neighborhood had the highest number of positive COVID-19 cases any neighborhood
18	in San Francisco; and
19	WHEREAS, In response to the devastating effect COVID-19 had on the Latinx
20	population in San Francisco, Mission leaders, activists and community organizations founded
21	the Latino Task Force on COVID-19 to support and advocate for the most effected in our city;
22	and
23	WHEREAS, On April 19, 2020, to better understand the effects of COVID-19 and
24	address the needs of the Latinx population in the Mission, the Latino Task Force on COVID-
25	19 partnered with the University of California San Francisco, a major healthcare provider in

1 San Francisco, to study why the Latinx community was being so hard hit and to develop a 2 response, to together form Unidos en Salud; and

WHEREAS, A major goal of Unidos En Salud was to reach the most vulnerable residents in San Francisco with a culturally and linguistically appropriate program; and

5 WHEREAS, Unidos en Salud's first act was to do a study in the Mission and in the 6 census tract with the highest population of Latinx people in the city, which yielded vital 7 information about who was getting COVID-19 and major factors contributing to high infection 8 rates in the Latinx community; and

9 WHEREAS, The information derived from the Unidos en Salud study was used to 10 develop critical programs such as Right to Recover, Mission Hub testing, and the test to care 11 model, used to guide people from diagnosis to recovery in a culturally appropriate way; and 12 WHEREAS, Unidos en Salud founded and operated the first community vaccination site in San Francisco that now vaccinates up to 500 people a day, and plays an essential role 13

14 in San Francisco vaccine rollout and for recovery; now, therefore, be it

15 RESOLVED, That the San Francisco Board of Supervisors recognizes the vital role 16 Unidos en Salud has played in recovery of our City and lifesaving programs and resources 17 they have provided to the Latinx community in San Francisco.
