### What does a panelist do?

- Ensure the transparency of OEWD's grantmaking practices.
- Review, rank, and comment on grant applications in the category that's specific to their expertise.
- Meet in a virtual setting where panel discussions may be recorded.
- Receive compensation for each application reviewed.

### Why be a panelist?

- It's a great networking opportunity.
- Learn about people, organizations, and projects in the works.
- You have a voice in deciding funding recommendations for project proposals.
- It's all virtual this year.
- Panelists receive payment.

### What are we looking for in a panelist?

- A strong connection to one or more of San Francisco's communities and neighborhoods (you do not need to currently be a resident to apply).
- Practicing professionals with deep knowledge and experience in diverse categories such as: growing a business, career and vocational training, community organizing, promising practices for nonprofits, event planning and programming, emerging technologies, innovative solutions for social change, facility, and capital needs.
- Experience growing economic opportunities for businesses or individuals, and in advancing cultural and racial equity.
- Someone with an interest in taking a behind-the-scenes look at the grant-making process.
- Someone who is representative of both San Francisco's demographics and the specific 2020 applicant pool in terms of race/ethnicity, gender, LGBTQ, and differently-abled representations.

### FAQs

#### I am a current grantee, can I be a panelist?

Yes, you can!

#### I am applying for a grant, can I be a panelist?

Yes, just not for the grant you applied to.

#### Who curates the review panel and selects the panelists?

The Program Officer administering the grant category.

#### I'm living outside of the Bay Area right now, can I apply?

Yes! We want people with strong connections to San Francisco neighborhoods

and communities.
