Subject: Resolution designating Outreach Newspapers for FY 10-11

I am enclosing the resolution that would designate the City's outreach newspapers for next fiscal year. OCA received responsive bids from one paper each for the Hispanic and Lesbian-Gay-Bisexual outreach communities. As a result, the resolution would designate El Reportero and the Bay Area Reporter for their respective communities. OCA received only non-responsive bids for the African American and Chinese outreach communities. All bidders for those communities were non-responsive because the papers are not printed in San Francisco, and some bidders had additional problems, detailed in this memo's second enclosure.

In accordance with the Administrative Code, OCA ranks the bidders according a point scale and recommends to the Board the highest-scoring responsive bidder for each outreach community. Historically, the Board has awarded contracts to more bidders than OCA has been able to recommend.

The attached table, "Summary of Outreach Bids for FY 10-11," shows the following:

- papers OCA sent the outreach bid package to
- papers that responded
- each bidder's outreach community or neighborhood
- bid prices
- which bidders are responsive and recommended and so included in the resolution
- which papers were designated by the Board for FY 09-10.

The attached "Detailed Comparison of Outreach Bids" shows the point calculations required by the Administrative Code.

OCA has notified all bidders of the status of their bids.

For several years, OCA has notified neighborhood newspapers of the outreach newspaper bid. This year we notified some additional neighborhood papers and, for the first time, we received bids from two of them. The *Western Edition* submitted a bid for the Western Addition neighborhood, and the *West Portal Monthly* submitted a bid for the West Portal neighborhood. Administrative Code Section 2.81-4 authorizes the Board to authorize advertising in monthly neighborhood publications if the Board finds that a neighborhood is not adequately served by an outreach paper.

The attached bid summary notes that the West Portal Monthly's bid was responsive and that the Western Edition's was not because it was late. In case the Board wishes to designate a neighborhood outreach newspaper, OCA has drafted the enclosed resolution to include the West Portal Monthly as the designated paper for the West Portal neighborhood.
