off-sale beer and wine license to a retail wine store

At the present time, the Planning Department cannot recommend approval to add ABC License Type 20 to the proposed retail wine store dba Vino Nostro at 1455 Van Ness Avenue within an RC-4 (Residential-Commercial Combined, High Density) Zoning District.

The proposed retail wine store is considered a liquor store use pursuant to Planning Code Section 790.55. Within the RC-4 Zoning District, the proposed liquor store use is not currently permitted as a principally permitted use within the nearest NC Zoning District. However, in late 2010, there are proposed Planning Code text amendments which would amend the RC-4 Zoning District controls which would allow your proposed liquor store use as a permitted use within the nearest C-2 (Community Business) Zoning District.
