San Francisco values representing all communities of interest equally. It is why I moved to the Haight Ashbury neighborhood 30 years ago. From the beginning, I supported my neighbors, housed and unhoused, hosting an annual community block party, organizing tree plantings, and most recently providing meals and human/pet supplies at the Safe Sleeping Site on Stanyan. What is particularly appealing to me about the animal community of San Francisco is that animal guardians represent every income level, ethnicity, race, gender, age, ability, and sexual orientation. The common bond is compassion for animals. It has been a privilege to raise awareness and funds for the animals, advocate for them, and serve the people who care for them. It would be an honor to renew my role as a commissioner on the Animal Control and Welfare Commission.

My professional experience includes event management and fundraising for non-profits in the Bay Area. In 2018, I received a Master in Nonprofit Administration at the University of San Francisco and now provide consulting services for local non-profits. Although I have had many rewarding jobs, including several years at the San Francisco Chronicle managing over 20 events annually - volunteering at San Francisco Animal Care and Control has been the most meaningful. I began in 1993 socializing animals and working with potential adopters. In 1994, I created and organized Pet Pride Day, an annual event in Sharon Meadows in Golden Gate Park in October. This free event was open to the public (and their pets) to come and celebrate the animals. In addition to raising funds and awareness for ACC, it also showcased the sweet, quirky animal-loving residents that call San Francisco home. Until 2015, I served as Co-President of Friends of San Francisco Animal Care and Control (Friends of ACC), a non-profit I helped establish in 2000. Friends of ACC raises funds for programs and services that extend beyond ACCs operating budget.

Civic Activities:

The Commission offers many opportunities to engage in civic activities. In 2020, I used my experience in animal welfare to support the companion animals at the Safe Sleeping Site on Stanyan. I was able to provide supplies, veterinary care, and food. Besides pet food/supplies, I, along with a Cole Valley Haight Allies (CVHA) neighborhood team, offer homecooked meals, supplies, and support for the residents. Keeping companion animals and their guardians safe during this crisis became an objective of the Animal Control and Welfare Commission (ACWC) in 2021. Our commission work plan reflects the civic efforts of each commissioner. The safety and care of unhoused people and pets is a particular interest of mine.

As part of the ACWC, I also serve as an animal welfare advisor on the Joint Zoo/Rec and Park Committee. Currently, I am helping the committee develop a building usage plan for the Mothers Building - a historic building located on Zoo property

I have been employed at Golden Gate University since 1990. I have held various job positions during my time working at the university, and I have held my current position of Operations Manager since 2004. In my position as Operations Manager, I oversee many of the university's administrative responsibilities to include purchasing, scheduling, and security. In addition, I also serve as a Title IX Coordinator for the university, as well the administrator for our EthicsPoint/anonymous reporting system. The administrative experience that I have gained while working at the university, as well as my attention to detail, are skills that I also bring to my work as a Commissioner.

Concerning animal issues, I have volunteered and donated to various animal organizations throughout the years - with a devoted emphasis on those organizations that help animals who are older, or have special needs. I feel it is a real honor to be able to volunteer time, and donate other resources, to help animals; and I feel blessed to have experienced what I believe is a real calling, and that I have the ability to help animals in any way that I can.

Civic Activities:

I have always considered myself an adovcate and community organizer, and I try to do what I can to help others. It was my hope to do more for the community that inspired me to first apply for a seat on the Commission of Animal Control and Welfare back in 2019. Through my work on the Commission, I have become more active - and have recently started volunteering with the Latino Task Force and the SF Dog organization to help with food preparation at the Mission Food Hub. In addition, I have volunteered with various animal rescue organizations, such as Muttville Senior Dog Rescue and the Doris Day Animal Foundation. Previously, I worked with community organizations, like the All People's Congress, to organize speak-outs and demonstrations, including some of the biggest anti-war marches in the City since the Vietnam War. I was also one of the early volunteers with Prevention Point Needle Exchange, joining when they were looking for people of color within the community to be involved. I also volunteered with Community United Against Violence (CUAV) working on their domestic violence crisis phone line, and as a crime victims' advocate. I have also volunteered for various local and state-wide political campaigns, including doing advance work for Kamala Harris's first campaign for San Francisco District Attorney, and for Gloria La Riva's campaign when she ran as the Peace and Freedom Party's candidate for Governor of California.

As a commissioner, I try to ask the questions and gather the perspectives that will give us the full picture required for decison-making. Although it has not always been a popular approach, I believe it is the best way to fulfill our duty.

I began volunteering with animal organizations over a decade ago, after bonding with an animal for the first time - a Shih Tzu named Charlotte. I started working at local adoption events, and later trained and worked as a dog socialization volunteer at the SF SPCA. I soon realized my legal training could be of use, and signed up as a volunteer advocate with the Humane Society of the United States, working to pass animal-friendly legislation at the local, state, and federal levels. Through my work with HSUS, I learned of the Commission and have been serving the past two years, first as Secretary, and currently as Chair.

Civic Activities:

During my first term, I've had the opportunity to make policy recommendations and host public discussions to advance animal welfare. My work has included supporting: activists exposing conditions on factory farms, food purchasing standards encouraging city departments to increase plant-based purchases, California's prohibition on eggs, veal and pork produced from caged animals, and state bills encouraging plant-based meals in schools and subsidies for farmers transitioning away from animal agriculture. This year, we are focusing on supporting people and animals in crisis, including homeless residents and domestic violence survivors and their companion animals.

The Commission of Animal Control and Welfare consists of eleven (11) members.

The seven (7) members appointed by the Board of Supervisors shall be voting members: > Six (6) members shall represent the general public and have interest and experience in animal matters; and

> One (1) member must be a licensed veterinarian practicing in San Francisco.

The other four (4) members are non-voting members, as follows:

> One (1) member shall consist of the Director of the Animal Care and Control Department or his/her designated representative;

> One (1) member appointed by the Director of the Department of Public Health or his/her designated representative;

> One (1) member appointed by the Chief of Police or his/her designated representative; and
 > One (1) member appointed by the General Manager of the Recreation and Park Department or his/her designated representative.

Each member of the Commission of Animal Control and Welfare of the City and County of San Francisco shall be a resident of the City and County of San Francisco, except for the licensed veterinarian, who must practice in San Francisco, but who need not be a resident of San Francisco.

The Commission shall have the powers and duties to: a) hold hearings and submit

recommendations regarding animal control and welfare to the Board of Supervisors and the City Administrator; b) study and recommend requirements for the maintenance of animals in public, private, and commercial care; and c) work with the Tax Collector, Director of the Animal Care and Control Department, and authorized licensing entities to develop and maintain dog licensing procedures and make recommendations on fees.

Term of Office: Three of the members who are first appointed by the Board of Supervisors shall be designated to serve for terms of one year and three for two years from the date of their appointment. Thereafter, members shall be appointed as aforesaid for a term of two years, except that all of the vacancies occurring during a term shall be filled for the unexpired term. A member shall hold office until his or her successor has been appointed and has qualified.

Reports: The Commission shall render a written report of its activities to the Board of Supervisors quarterly as stated in Health Code, Section 41.3.

Thank you for your consideration of my application to the Commission of Animal Control and Welfare. I appreciate the opportunity to speak to the Board of Supervisors Rules Committee on May 17th.

Prior to the meeting I wanted to introduce myself and provide a brief summary of my qualifications:

Passion for and appreciation for animals: A life-long pet lover and guardian, I grew up with a lot of pets. Usually 3-5 cats, one or two dogs, mice or hamsters, goldfish and a canary at any given time. I am currently the proud mom of Sneakers, a gray tabby adopted from ACC over 10 years ago, and Nika, our Akita adopted 11 years ago from a local rescue group. I also live close to Mountain Lake Park and the Presidio and adore the abundant local wildlife – hawks, owls, gophers, squirrels, coyotes, raccoons, skunks and the rare fox.

Volunteer experience with Animal Care and Control: Over 5 years ago my daughter and I went through the ACC volunteer orientation and became volunteers with Toni's Kitten Rescue (TKR). Since then I have had the exquisite pleasure of fostering over 150 ACC kittens. In that time I have gotten to know ACC extremely well – the staff, the volunteers and the facility (although I have only been to the outside of the new facility due to COVID). During my many visits there I have also got to see countless community interactions between the public and the dedicated ACC staff and volunteers. In addition, several years ago I organized a community support event at my employer involving over 100 people to make 25 pet beds and 170 pet toys and raise almost \$1000.00 for Friends of ACC.

Volunteerism and civic engagement: Besides my involvement with ACC/TKR, I volunteer with NAMI (National Alliance on Mental Illness) as a parent support group facilitator and course instructor. Irina Ozernoy asked me to send an email to you in support of her application to join the San Francisco Commission of Animal Control & Welfare. I am happy to do so because I know her to be a thoughtful, intelligent, and collaborative person interested in animal protection and welfare. She demonstrated remarkable initiative when a neighbor illegally trapped a raccoon and had her killed. As someone who had appreciated all the wildlife in her neighborhood without sentimentalism or inappropriately feeding wildlife, she expressed shocked disappointment to see a neighbor behave unnecessarily and, ultimately, fruitlessly to achieve misguided "wildlife management" objectives. She has turned that experience into an opportunity to engage with wildlife rescue and rehabilitation efforts by volunteering with an organization focused on urban wildlife protection. Her positive attitude is contagious, and her thoughtfulness bodes well for collaborative approaches to solving animal welfare and protection issues in San Francisco.

I actually came to know Irina's partner first, as he was a student in my animal law class at UCLA Law.
