







Challenges:

- Takes too long to get clients into treatment
- Limited treatment options
- Ongoing complaints
- Nowhere to escape drug use

4 STEP PLAN TO RECOVERY

- 1.) Make a decision to change.
- 2.) Talk to your case manager about Recovery Pathways.
- 3.) Commit. Experience progress.
- 4.) Meet goals. Feel success. You are re-gaining control of your life.



TREATMENT & SUPPORT

Treatment can be life changing: Whether it's your first time or not, treatment can work for you.

When all other life bridges are broken, a positive support system and commitment to recovery can open doors to a life you couldn't imagine.



(Up to 24 months)

Eligibility: Clients of the Adult Probation Department.

Your success matters!

As you successfully complete treatment, you will be prioritized into transitional housing.

There are TWO TREATMENT and SUPPORT pathways to success



Pathway #1

90-DAYS

Complete 90-days of a licensed residential treatment program and transfer to supportive housing.

Men- Westside - Lower Haight Women - Her House - Lower Haight

- Up to one year, then transfer to New Horizons for another year
- Shared/Single Rooms
- Clean & Sober, Communal Living
- Case Management
- Life Goals & Permanent Housing Support


Pathway #2

180-DAYS

Complete 180-days of a licensed residential treatment program and transfer to New Horizons/SRO.

THC/New Horizons - Tenderloin

- Up to one year
- Single Rooms
- Clean & Sober
- Case Management
- Life Goals & Permanent Housing Support



Working Group Recommendations:

Expand Drug/Alcohol Treatment Options:

Include Residential Abstinence Based Treatment Programs, Social Model/TC Treatment Programs, Faith Based and 12 Step Treatment Programs, Harm Reduction Strategies, Safe Consumption Sites.

Include the Voice of People in Recovery:

Ensure individuals in Recovery are at the table when the City is making policy decisions regarding Addiction, Recovery, and Treatment.

Extend Drug/Alcohol Treatment Stays:

Treatment should not be bound by Drug Medi-Cal. San Franciscans should have access to drug and alcohol treatment programs ranging from 90 days to 1 year or more, based on the needs of the individual.

Create Specialized Residential Drug Treatment Programs for TAYA:

Young people have different needs than adults. Drug treatment should be specialized to meet the needs of those ages 16-25.

Fund a Black led Abstinence Based Treatment Program in the Bayview:

To meet the culturally sensitive treatment needs of black people and people of color who live in the Bayview - provide treatment which is abstinence based in its approach to working with addicted and criminal justice populations in SF.

Expand Paid Peer Specialists Opportunities:

Train and Connect those in recovery with people working toward recovery. People who successfully complete treatment should have access to paid positions helping others struggling with addiction.

Increase Awareness About Available Drug Treatment Services:

Ensure individuals suffering from addiction can access real time information about treatment options.

Treatment on Demand

- How to Meet the Treatment Needs of Justice-Involved People
 - Expand Treatment Options
 - Extend Treatment Stays
 - o Increase Dual Diagnosis and MH Treatment Beds
 - Remove Barriers to Access Drug Treatment
- What is APD Doing to Support the Ongoing Recovery Needs of Justice-Involved People
 - Fund residential treatment and detox beds
 - Connect clients to Medication Assisted Treatment (MAT)
 - Provide the following services at the CASC:
 - Clinical and Reentry Case Management
 - Contingency Management
 - Medication Management
 - Outpatient Drug Treatment
 - Clinical Therapy
 - The CASC is home to DPH's STARR Program
 - Develop Community Support Networks Through:
 - Positive Directions Equals Change
 - Sister's Circle
 - Solutions for Women
 - Mentoring Men's Movement
 - Because Black is Still is Still Beautiful
 - o Extensive portfolio of transitional housing programs
 - Recovery Pathways Prioritizing clients into housing who complete treatment
- How is APD Expanding Access to Treatment
 - Strategies Include:
 - Treatment as an Alternative to Incarceration (jail/prison)
 - Extensive Outreach to Clients with Behavioral Health Needs
 - DPH STARR
 - Investing in Programs that Meet the Needs of our Clients
 - Listening to the Community
