[Registration Fees for Inspecting and Testing Commercial Weighing and Measuring Devices]

Ordinance amending the San Francisco Administrative Code, Chapter 1, by amending Section 1.13-5 to update registration fees for inspecting and testing commercial devices as authorized by California Business and Professions Code Sec. 12210.5 and set by the California Department of Food and Agriculture, and deleting obsolete language.

Be it ordained by the People of the City and County of San Francisco:

Section 1. The Planning Department has determined that the actions contemplated in this Resolution are in compliance with the California Environmental Quality Act (California Resources Code sections 21000 et seq.). Said determination is on file with the Clerk of the Board of Supervisors in File No. 100717

, and is incorporated herein by reference; and

Section 2. The San Francisco Administrative Code is hereby amended by amending Section 1.13-5, to read as follows:

SEC. 1.13-5. WEIGHTS AND MEASURES—PERMITS AND FEES

(a) Registration Fees. All weighing and measuring devices <u>used for commercial</u> <u>purposes, as defined in subdivision (e) of Section 12500 of the Business and Professions Code, shall be registered annually with inspected or tested by the County Sealer of Weights and Measures. <u>pursuant to Business and Professions Code Section 12210 shall be registered annually with the County Sealer.</u> The fee charged by the County Sealer for such registration shall be used to offset the costs of inspecting and testing <u>of said devices pursuant to Section 12240 of the Business and</u></u>

<u>Professions Code and to recover the cost of carrying out Business and Professions Code Section</u>

12211.

- (b) Calculation of Fees. The amount of the fees shall be set to recover the total costs of inspection and testing incurred by the County Sealer for each annual registration, but shall not exceed the maximum annual charges authorized under California Business and Professions Code Section 12240. Each registration fee shall include both a business location component and a device fee component. The registration fees shall be *phased-in-according* to the following schedule:
- (1) Beginning January 1, 2006, the registration fee shall be sixty dollars (\$60) per business location, plus 60 percent of the maximum device fee listed in subsections (c)(1) (7) below;
- (2) Beginning January 1, 2007, the registration fee shall be eighty dollars (\$80) per business location, plus 80 percent of the maximum applicable device fee listed in subsections (c)(1) (7) below;
- (3)—Beginning January 1, 2008, and thereafter, the registration fee shall be one hundred dollars (\$100) per business location, plus <u>a_100 percent of the maximum-applicable</u> device fee listed in subsections (c)(1)—(7) below.
 - (c) Device Fees.
- (1) For large capacity weighing devices, other than livestock, with capacities of 10,000 pounds or greater, the device fee shall not exceed two hundred fifty dollars (\$250) per device;
- (2) For smaller capacity weighing devices, other than livestock scales, with capacities of a least 2,000 pounds but less than 10,000 pounds, the device fee shall not exceed one hundred fifty dollars (\$150) per device;
- (3) For livestock scales with capacities of 10,000 pounds or greater, the device fee shall not exceed one hundred fifty dollars (\$150) per device;
- (4) For livestock scales with capacities of at least 2,000 pounds but less than 10,000 pounds, the device fee shall not exceed one hundred dollars (\$100) per device;

- (5) For liquefied petroleum gas meters, truck mounted or stationary, the device fee shall not exceed one hundred seventy-five dollars (\$175) per device.
- (6) For wholesale and vehicle meters, the device fee shall not exceed twenty-five dollars (\$25) per device;
- (7) For all other commercial weighing or measuring devices not listed above, the device fee shall not exceed twenty dollars (\$20) per device. For purposes of this subsection (c)(7), the total annual registration fee shall not exceed the sum of one thousand dollars (\$1,000) for each business location.
- (d) Business Locations. For purposes of this Section, a single business location is defined as: (1) each vehicle containing one or more commercial devices; or, (B) each business location that uses different categories or types of commercial devices that require the use of specialized testing equipment and that necessitates not more than one inspection trip by a weights and measures official.
- (e) Utility Meters. For marinas, mobilehome parks, recreational vehicle parks, and apartment complexes, where the owner of the marinu, park, or complex owns and is responsible for the utility meters, the device fee shall not exceed two dollars (\$2) per device per space or apartment. Marinas, mobilehome parks, recreational vehicle parks, and apartment complexes for which the above fees are assessed shall be inspected and tested as frequently as required by regulation. The electric meter and gas vapor meter of a mobile home park, recreational vehicle park, and apartment complex, where the owner of the park or complex owns and is responsible for the utility meters, shall be inspected and tested as frequently as required by regulation. An annual fee of \$60 per park or complex, and a fee of \$2 per space or apartment unit shall be collected from the owner of the park or complex for the inspection and testing of the meter.
- (f) Rules and Regulations. The County Sealer shall promulgate such rules and regulations as are reasonable and necessary to implement this ordinance.

LEGISLATIVE DIGEST

[Registration Fees For Inspecting and Testing Commercial Weighing and Measuring Devices]

Ordinance amending the San Francisco Administrative Code by amending Section 1.13-5 to update registration fees for inspecting and testing commercial devices as authorized by California Business and Professions Code Sec. 12210.5 and set by the California Department of Food and Agriculture, and deleting obsolete language.

Existing Law

Section 1.13-5 of the San Francisco Administrative Code sets forth registration fees for inspecting and testing commercial weighing and measuring devices. Section 1.13-5 also provides that the fees shall be set to recover the total costs of inspection and testing incurred for each annual registration, but shall not exceed the maximum annual charges authorized under State law.

Amendments to Current Law

The amendment would increase the registration fees established under existing law. The fees established under the amendment are set to recover the total costs of inspection and testing incurred for each annual registration, but do not exceed the maximum annual charges authorized under State law.
