San Francisco Pretrial Diversion Project – History/Overview

1964 Own Recognizance (OR) Project

- Established process for alternative to cash bail
- Independent agency services included minimal level of pre-trial client supervision
- 1976 San Francisco Pretrial Diversion Project (SFPDP)
 - Independent non-profit contracting with Sheriff's Office
 - Diverted misdemeanor clients from pre-trial custody
- 1994 Sheriff's Office and SFPDP established supervised pre-trial release
 - Expanded population eligible for pre-trial release
 - Supervised pre-trial release now referred to as Assertive Case Management (ACM)
- 2006 SFPDP assumed work of OR Project
 - Merger into one independent agency
 - Services for clients with varying levels of acuity to divert them from pre-trial custody



San Francisco Pretrial Diversion Project – History/Overview

2015 Public Safety Assessment (PSA) implementation

- Developed by Arnold Foundation and used by Pretrial
- Blind process to assess likelihood of court-appearance/safety during pre-trial release

2018 Court of Appeal Ruling: In Re Humphrey


- Release conditions must consider ability to pay and non-monetary alternatives
- Additional SFPDP clients who before would be held in custody in lieu of bail
- SFPDP workload increased >50% from FY17-18 to FY18-19

2019 Federal Court Ruling: Buffin vs. San Francisco

- Prohibits application of California bail schedule
- Set strict timelines for pre-arraignment detention
- Accelerates SFPDP timeline for completion of PSAs, requires 24/7 coverage
- Additional SFPDP clients who before would access bail
- 2021 Contract Approval Request
 - Provides for services from 07/01/2021 through 06/30/2024
 - San Francisco Pretrial workload more than doubled since start of prior grant agreement



Pretrial Assessment/Supervision Process







Appearance & Safety Rates by Year



Progression of Pretrial Custodial/Non-Custodial Decisions

June 1, 2016

- 2,147 Est. jail population without alternatives to incarceration
- **1,351** Actual jail population
 - 796 Individuals out of custody on pretrial release and sentenced to alternatives

June 1, 2021

- 2,634 Est. jail population without alternatives to incarceration
- 805 Actual jail population
- 1,829 Individuals out of custody on pretrial release and sentenced to alternatives
