WHEREAS, The Board of Supervisors Resolution No. 546-20 approved the Second
 Amendment to the contract with Off the Grid Services LLC extending the term through May
 28, 2021 and increasing the total not to exceed amount to \$28,710,000; and

WHEREAS, The Human Services Agency entered into the second amendment of the

contract with Off the Grid Services LLC to extend the term through May 28, 2021 and increase
the total not the exceed amount to \$28,710,000; and

WHEREAS, The Human Services Agency wishes to amend the contract with Off the
Grid Services LLC, effective on and after May 29, 2021, to increase the contract amount by
\$17,283,000 for a revised not to exceed amount of \$45,993,000 and to extend the contract
through December 31, 2021; and
