

*"[W]hen there is evidence suggesting that"* the economic and social effects caused by the proposed [project] ultimately could result in urban decay or deterioration, then the lead agency is obligated to assess this indirect impact...The lead agency cannot divest itself of its analytical and informational obligations by summarily dismissing the possibility of urban decay or deterioration as a "social or economic effect" of the project."

"Where there is a **reasonable possibility** of a significant effect due to unusual circumstances surrounding the project, it is not exempt even if it clearly fits one of the [exemption] categories."
