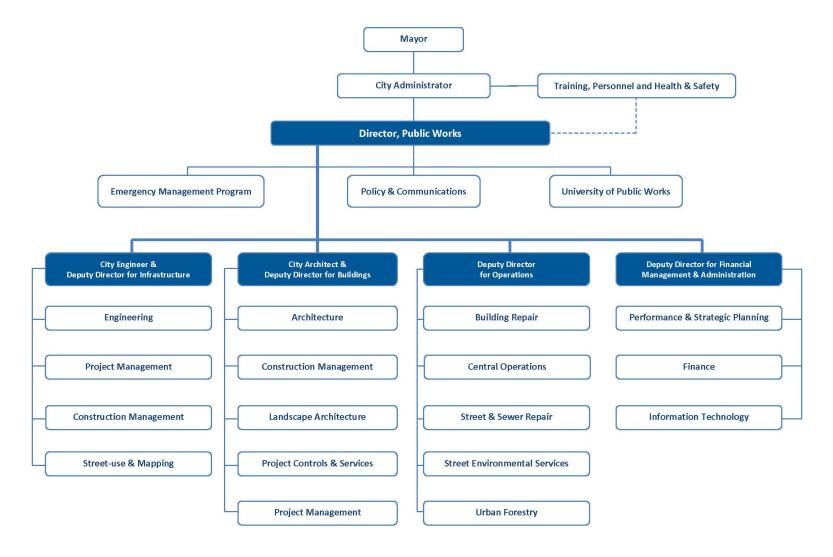

Capital Programs







Street Resurfacing / Paving Program

- Paved 400 blocks in FY21.
- Current citywide Pavement Condition Index score is 75.
- No General Fund support in FY22 and FY23. FY22 goal is to pave 500 blocks with funding support from 2020 Health and Recovery Bond and State Gas Tax.

Curb Ramp Program

- General Fund only for inspection and replacement of detectable tiles.
- \$5M from 2020 Health and Recovery Bond for 120 curb ramps and \$4M from Certificates of Participation for curb ramps with subsidewalk basements.

Right-of-Way Renewal

- Limited General Fund for street structure and plaza inspection and repair, sidewalk repair, and median maintenance.
- Approximately 20 structures and 2 plazas will be repaired with \$5M from 2020 Health and Recovery Bond.

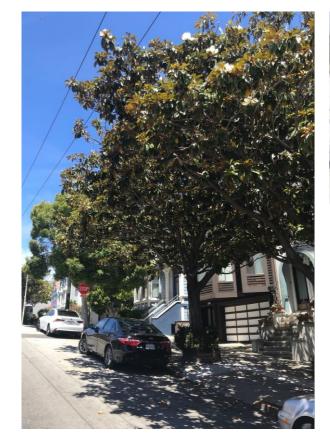
Critical Enhancements/Discrete Projects

- \$400,000 in local match for Alemany Interchange Improvements Phase 2
- \$3 million for street tree planting and establishment
- \$300,000 for Harvey Milk Plaza
- \$2.7 million Stockton Street sidewalk widening



Budget Gaps and Inequities

- A focus on geographic equity across all neighborhoods
 - Street Resurfacing
 - Curb Ramps
 - StreetTreeSF
- District addbacks and community input
- Workforce development for those with barriers to employment









Support of Small Businesses

- Helped develop and execute Shared Spaces program
 - 2,500-plus permit applications,
 70% approval rate
 - Legislative plans are underway to develop a permanent Shared Spaces program
- Initiated a targeted deep-cleaning operation in neighborhood commercial corridors through the CleanCorridorsSF initiative
- Courtesy graffiti abatement on storefronts in the hardest-hit areas during Stay-at-Home Order









COVID-19 Response

- Expanded Pit Stop public toilets to 60 locations in 15 neighborhoods
- Built Safe Sleeping Sites and provided enhanced cleaning around encampments
- Secured Market Street underground rail stations
- Prepared testing and vaccination sites
- Distributed food and PPE to underserved and negatively impacted communities
- Enhanced sidewalk cleaning around emergency food distribution sites

Rebuilding Public Trust

- Mandatory ethics training for all Public Works employees
- Transparency through public hearings, community meetings and website
- PublicWorksStat performance measures and active projects available online
- Training leaders on process improvement
- Bolstered contracting oversight process
- Mandatory, streamlined reviews on contractor performance





System Changes and Innovation

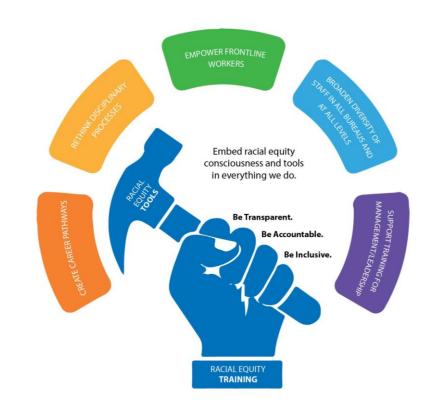
- Updated GIS System with new servers, software, data transformations and base map maintenance
- Right-of-Way Software to provide a modernized approach to managing and coordinating the development of assets located in the public right of way with real-time map views
- Permitting and Inspections application with 60-plus permit types and an updated online application process

- Project and Construction Management
 System Implementation System with software to better manage construction and project delivery
- Connected Worker Application to allow Community Benefit District staff to access and close-out Public Works' 311 service requests, eliminating duplicate efforts
- Shared Spaces Permit Portal: collaboration with Digital Services and SFMTA
- Street Sweeping Route Editing and Navigation Tool: collaboration with Office of Civic Innovation



Racial Equity

- Develop and integrate racial equity tools in team and project planning, including staffing, process, budget, roles and decision-making
- Use racial equity tools to conduct budget analysis on how we provide services to the community
- Embed racial equity consciousness in departmentwide initiatives, including strategic planning, performance plans, process improvement strategies, mandatory trainings and new employee orientation
- Support racial equity frontline leaders by including the initiative in their job descriptions and deliverables
