15 Be it ordained by the People of the City and County of San Francisco:

16 Section 1. Article III of the Campaign and Governmental Conduct Code is hereby
17 amended by revising Section 3.1-103 and adding Section 3.1-417, to read as follows:

18 **SEC. 3.1-103. FILING OFFICERS.**

19 Persons holding designated positions shall file the specified statements, declarations,
20 and certificates with the filing officers designated in this Section.

22 (1) Members of the following boards and commissions shall file their Form 700
23 Statements of Economic Interests, Sunshine Ordinance Declarations, and Certificates of

19 Section 2. Effective Date. This ordinance shall become effective 30 days after
20 enactment. Enactment occurs when the Mayor signs the ordinance, the Mayor returns the
21 ordinance unsigned or does not sign the ordinance within ten days of receiving it, or the Board
22 of Supervisors overrides the Mayor's veto of the ordinance.

24 Section 3. Scope of Ordinance. In enacting this ordinance, the Board of Supervisors
