1	[Approval of a 90-day Extension for Historic Preservation Commission Review of Initiation of
2	Landmark Status of The Allegory of California Mural at 155 Sansome Street]
3	Resolution extending by 90 days the prescribed time within which the Historic
4	Preservation Commission may render its decision on a proposed Resolution that
5	would initiate the designation of Diego Rivera's fresco, titled, "The Allegory of
6	California," at 155 Sansome Street as a landmark pursuant to Section 1004.1 of the
7	Planning Code.

9	WHEREAS, On April 6, 2021, Supervisor Peskin introduced a Resolution initiating a
10	landmark designation under Article 10 of the Planning Code for Diego Rivera's fresco, titled
11	"The Allegory of California," painted in 1931 and located at 155 Sansome Street (the
12	"Resolution"), a copy of which is on file with the Clerk of the Board of Supervisors in File No.
13	210352 and incorporated herein by reference; and
14	WHEREAS, On April 27, 2021, the Board of Supervisors unanimously adopted the
15	Resolution, and, on May 7, 2021, the Resolution was deemed finally approved; and
16	WHEREAS, Pursuant to Planning Code, Section 1004.2(b), the Historic Preservation
17	Commission has 90 days from the date of referral of the proposed designation to the Historic
18	Preservation Commission to approve, disapprove or modify the proposed designation; and
19	WHEREAS, The Board of Supervisors may, pursuant to Planning Code, Section
20	1004.2(b), extend the time within which the Historic Preservation Commission is to render its
21	decision by Resolution of the Board of Supervisors; and,
22	WHEREAS, Absent an extension, the Historic Preservation Commission's deadline to
23	act to approve, disapprove or modify the proposed designation is August 11, 2021, or 90 days
24	following the actual referral of the Resolution to the Historic Preservation Commission,
25	whichever is later; and
